RE: **DOCKET NO. 387** – SBA Towers II, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility at 44 Gavitt Road, Barkhamsted, Connecticut.

Directions to Site

Site is located at 44 Gavitt Road in the northeastern area of Barkhamsted.

From New Britain Area

- Take Route 72 westbound to Exit 1: Route 177/Washington Street
- Turn right onto 177 and follow northbound to intersection with Route 4 in Unionville Center
- At Route 4 intersection, bear left to follow Routes 4/179
- Follow Route 179 to intersection with Route 44 in Canton
- At Route 44 intersection, continue straight ahead to follow Route 179
- Route 179 will merge with Route 219 in Barkhamsted; bear right at merger
- Turn right immediately to follow Route 219 (Gavitt Road)
- Site will be a short distance on left—opposite red, two car garage

From Norfolk

- Take Route 44 eastbound to Route 318 in Barkhamsted
- Turn left onto Route 318; follow into Pleasant Valley; at stop sign at bridge, continue straight ahead over bridge to stay on Route 318
- After crossing Saville Dam, bear left to follow Route 219
- Route 179 will merge with Route 219 from right; immediately after merger, turn right to follow Route 219
- Site will be a short distance on left—opposite red, two car garage

From Hartford Area

- Take Route 44 (Albany Avenue) westbound and follow into Canton to intersection with Route 179
- At Route 179 intersection, turn right to follow Route 179 northbound
- Route 179 will merge with Route 219 in Barkhamsted; bear right at merger
- Turn right immediately to follow Route 219 (Gavitt Road)
- Site will be a short distance on left—opposite red, two car garage

From Enfield

- Take I-91 southbound to Route 20 westbound
- Follow Route 20 to West Granby; in West Granby, turn left onto Route 219 (Barkhamsted Road)
- Follow Route 219, which will become Gavitt Road in Barkhamsted
- Site will be on right—opposite red, two car garage

From Meriden

- Can take either I-91 northbound to Route 20 westbound, then follow Enfield directions or;
- Can travel to New Britain to take Route 72 westbound, then follow New Britain area directions

From Wolcott

- Can follow directions from either New Britain area or Fairfield and Milford

From Fairfield and Milford

- Take Route 8 northbound to end of highway in Winsted, then follow Route 44 eastbound to Route 318 in Barkhamsted
- Turn left onto Route 318; follow into Pleasant Valley; at stop sign at bridge, continue straight ahead over bridge to stay on Route 318
- After crossing Saville Dam, bear left to follow Route 219
- Route 179 will merge with Route 219 from right; immediately after merger, turn right to follow Route 219
- Site will be a short distance on left—opposite red, two car garage

From Stonington

- Take I-95 southbound to Route 9 northbound then, in New Britain, switch to Route 72 westbound and follow to Exit 1: Route 177/Washington Street
- Turn right onto 177 and follow northbound to intersection with Route 4 in Unionville Center
- At Route 4 intersection, bear left to follow Route 4/179
- Follow Route 179 to intersection with Route 44 in Canton
- At Route 44 intersection, continue straight ahead to follow Route 179
- Route 179 will merge with Route 219 in Barkhamsted; bear right at merger
- Turn right immediately to follow Route 219 (Gavitt Road)
- Site will be a short distance on left—opposite red, two car garage

Directions to Hearing

Hearing is at Barkhamsted Senior Center, 109 West River Road.

From Site

- Follow Route 219 westbound; turn left at intersection with Route 179 and then bear right to stay on Route 219
- From Route 219 bear right to follow Route 318 over Saville Dam
- After crossing bridge over Farmington River, turn right at stop sign onto West River Road
- Follow West River Road to Senior Center, which will be large white building on left (look for sign)

Directions to Restaurant

- Dinner is at Log House Restaurant, 110 New Hartford Road (Route 44), 860-379-8937
- From Senior Center, turn right onto West River Road
- At stop sign, with bridge on left, drive straight ahead to follow Route 181 southbound
- At intersection with Route 44, turn right; restaurant will be a short distance on right
