DOCKET NO. 388 - New Cingular Wireless PCS, LLC (AT&T) application for

a Certificate of Environmental Compatibility and Public Need for the

construction, maintenance and operation of a telecommunications facility located

at 1990 Litchfield Turnpike, Woodbridge, Connecticut.

#### I. Introduction

The application is from New Cingular Wireless PCS, LLC (AT&T) for the construction, maintenance, and operation of a 170-foot monopole telecommunications facility and associated equipment in the Town of Woodbridge, Connecticut. The facility would provide coverage in the northern Woodbridge.

The proposed site is located on a 20.8-acre parcel located at 1990 Litchfield Turnpike. The parcel is located in the Residential A Zone District.

#### II. Technical

The application includes relevant maps, descriptions of the proposed prime and alternate site, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. Council staff believes additional information can be obtained through prehearing interrogatories. This project would not require an outside consultant.

#### III. Administrative Review

The applicant has stated that all service and filing requirements pursuant to General Statutes § 16-501 (b) have been fulfilled. The applicant also stated that notice to the general public was published in the New Haven Register.

### IV. Procedural

The Council must schedule a hearing for the proceeding between 30 and 150 days after receipt of an application. The Council must also appoint a custodian of the docket and designate a place for the deposition of the transcript. Staff recommends designating Lisa Fontaine as custodian of the docket and depositing the transcript in the Woodbridge Town Hall.
