1. Does New Cingular Wireless PCS, LLC (AT&T) anticipate that blasting would be required during excavation?
2. In response to interrogatory number 10, set 1, AT&T indicated that the cost of antennas and radio equipment at the proposed site is estimated at \$250,000. Approximately how much of that total is associated with the antennas and how much is associated with the radio equipment?
3. Approximately when does AT&T anticipate the need to expand to PCS service?
4. In response to interrogatory number 13, set 1, AT&T provided the lengths of the existing cellular coverage gaps for Route 69, Downs Road, Route 63, and Route 67. Provide the individual lengths of proposed cellular coverage for each of those roads.
5. Approximately how many gallons of fuel would AT&T's backup generator fuel tank contain?
6. Would AT&T's backup generator meet all applicable noise standards at the subject property boundaries?
