Directions to Site

Site is located at 15 Orchard Park in Madison, Connecticut.

From Hartford, Norfolk, Enfield, Meriden, Fairfield, Milford, Wolcott, and New Britain

- Travel I-95 northbound to Exit 59 (Goose Lane)
- Take Exit 59, turn right at end of exit ramp and then take immediate left onto Route 1
 Boston Post Road
- Follow Boston Post Road to Mungertown Road (this road will be on left after strip of car dealerships: Ford, Lincoln/Mercury, and Jeep)
- Turn left onto Mungertown Road
- Turn right onto Orchard Park Road just before railroad bridge over Mungertown Road
- Follow Orchard Park Road to end and turn into driveway for 7 Orchard Park Road, follow to end of paved area

From Stonington

- Travel I-95 southbound to Exit 59 (Mungertown Road)
- Turn left at end of exit ramp onto Mungertown Road
- Take first left immediately after going under railroad bridge onto Orchard Park Road
- Follow Orchard Park Road to end and turn into driveway for 7 Orchard Park Road, follow to end of paved area

Directions to Hearing

Hearing is in the Upper Level of the Memorial Town Hall at 8 Meeting House Lane, Madison, Connecticut.

From Site

- Return to Mungertown Road and turn left
- Turn left onto Boston Post Road (Route 1)
- Turn left at first traffic light you come to on Boston Post Road
- Turn left into Memorial Town Hall parking area
- Memorial Town Hall is yellow brick building on right, next to Madison Chamber of Commerce

From I-95

- Take Exit 61 (Route 79 Madison)
- Travel southbound on Route 79 (Durham Road) to intersection with Route 1 (Boston Post Road)
- Turn right on Route 1 Boston Post Road
- Turn right at next traffic light and turn left into Memorial Town Hall parking area
- Memorial Town Hall is yellow brick building on right, next to Madison Chamber of Commerce
