

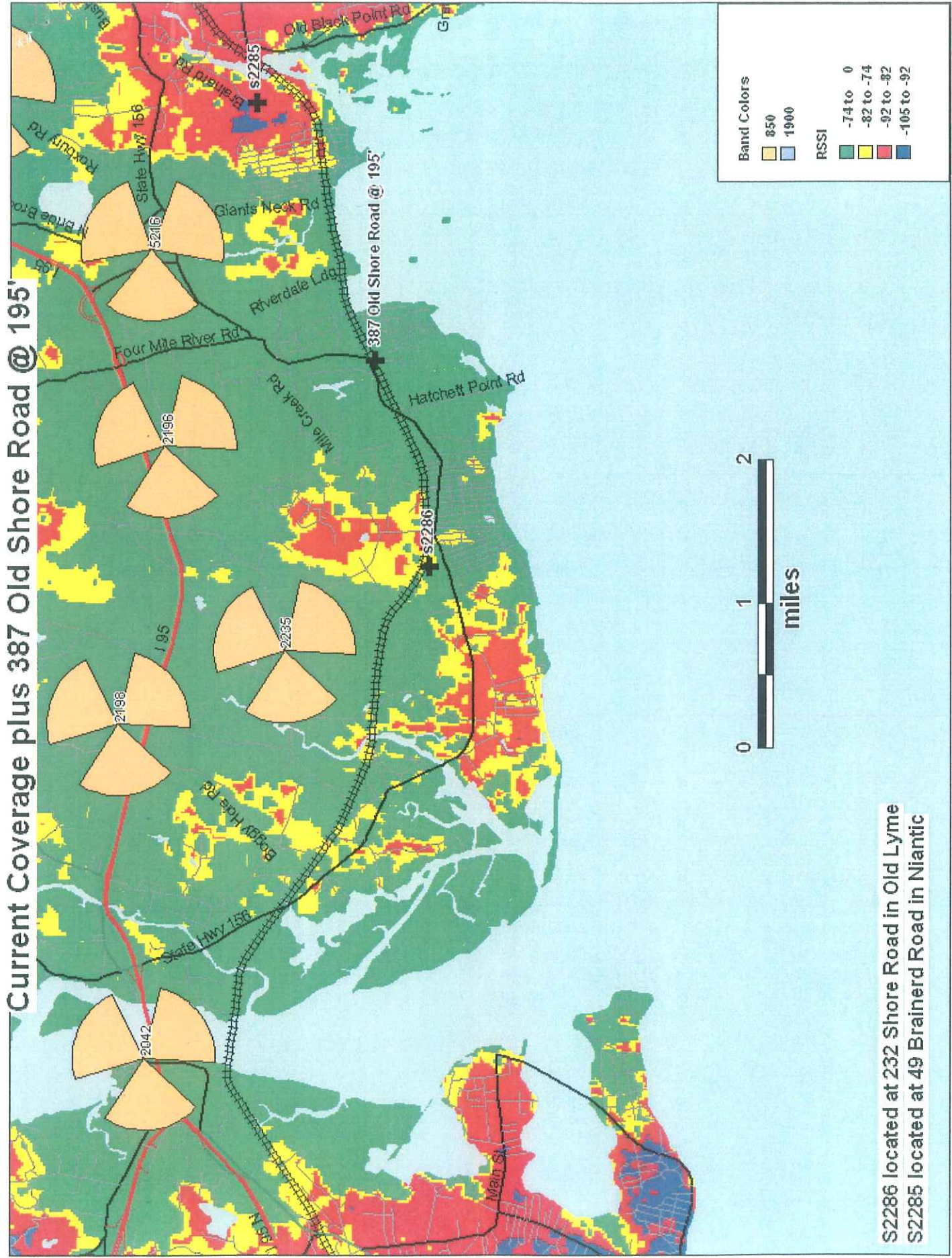

INTERVENOR NEW CINGULAR WIRELESS ("AT&T")
ANALYSIS OF TOWER LOCATIONS IN DOCKETS 392 AND 393

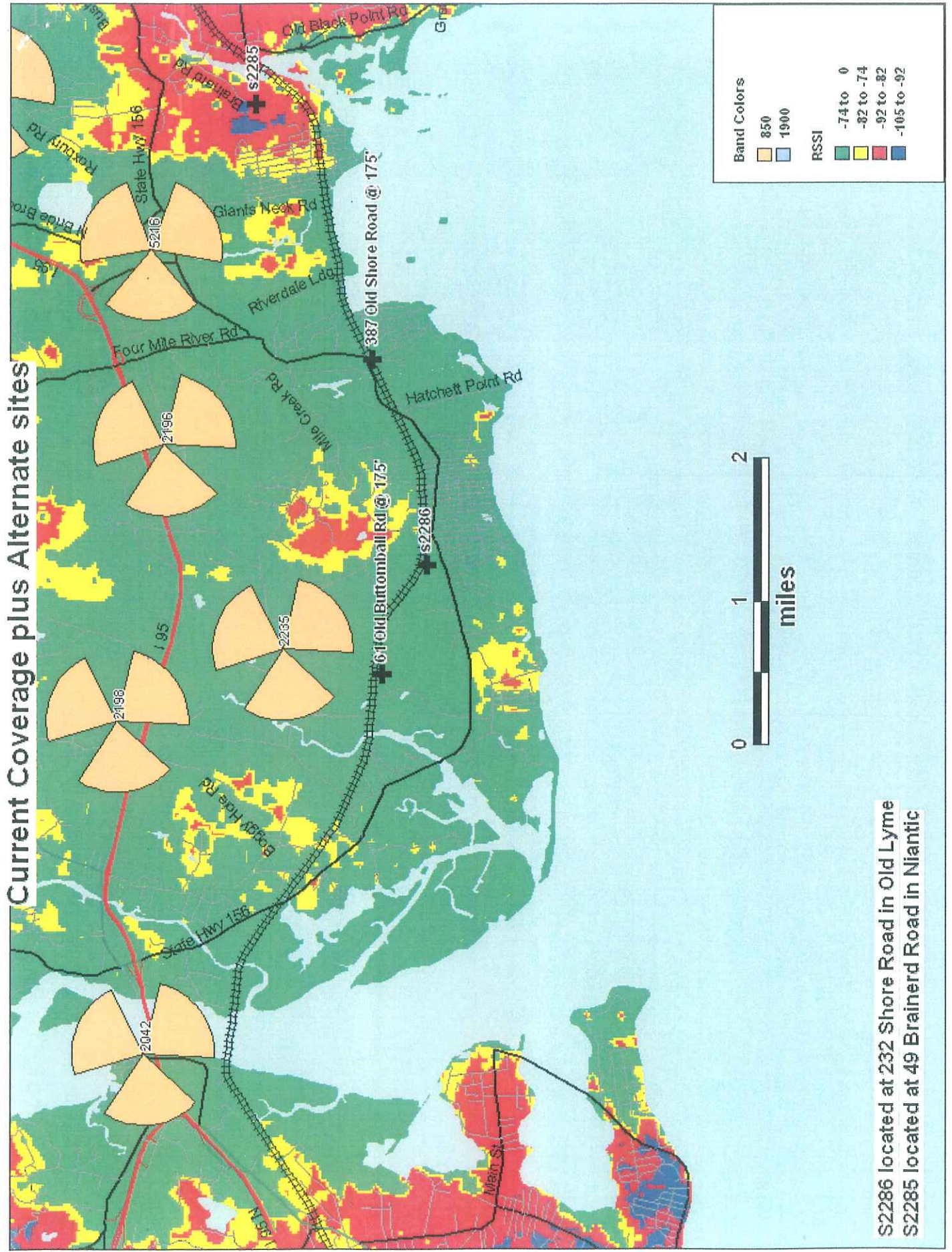
AT&T reviewed the tower locations proposed by T-Mobile in Dockets 391, 392 and 393 to identify sites that would serve its needs for coverage and subsequently intervened in Docket 391. AT&T conducted additional analysis of the two sites proposed in Dockets 392 and 393 and provides the following analysis regarding the ability of those sites to satisfy AT&T's identified need in the Town of Old Lyme:

1. 387 Shore Road/Docket 392: A tower located at 387 Shore Road would provide incremental improvement in conjunction with the proposed site at 232 Shore Road. 387 Shore Road would not replace 232 Shore Road even at 195' AGL due to its distance to the desired service area as per the attached coverage map ("Current Coverage plus 387 Old Shore Road @ 195"). Even together with a second tower at 61-1 Old Buttonball Road, a 387 Shore Road site will not provide all of the coverage that the proposed facility at 232 Shore Road can provide (see "Current Coverage Plus Alternate Sites").

2. 61-1 Old Buttonball Road/Docket 393: This location is too close to an existing AT&T site at 125 Mile Creek Road (AT&T Site CT2235) and coverage from this location would mostly be redundant with that existing site. Even in conjunction with a site at 387 Shore Road (both at 175' AGL) it will not provide comparable coverage to the proposed facility at 232 Shore Road as demonstrated on the attached coverage map marked Current Coverage Plus Alternate Sites.
