**T-MOBILE'S REQUEST FOR ADMINISTRATIVE NOTICE**

Pursuant to § 16-50j-28 (d) of the Regulations of Connecticut State Agencies, the Applicant, T-Mobile Northeast LLC ("T-Mobile"), respectfully requests that the Connecticut Siting Council take administrative notice of the cognizable facts, decisions, and evidence presented in Docket Number 202: Crown Atlantic Company LLC and Cellco Partnership d.b.a. Cellco Wireless application for a Certificate of Environmental Compatibility and Public Need. Docket Number 202 addressed a proposed 190 foot telecommunications facility on real property owned by the Intervenor, Black Hall Club, INC ("Black Hall") on Buttonball Road in Old Lyme. The location of the proposed facility would have been directly across the street from the Black Hall's golf course. As the owner of the land for the proposed prime site, Black Hall supported the installation of a 190-foot monopole on its property directly across the street from its golf course. Section 16-50j-28 (d) specifically allows the Council to take administrative notice of its prior decisions and orders. Docket Number 202 is relevant to the instant proceedings because it involved the Intervenor as the property owner for a telecommunications facility in the immediate vicinity of its golf course and bears directly on Black Hall's claim of visual impairment to its golf course.
