# SUBMISSION OF SUPPLEMENTAL EVIDENCE AND INFORMATION

Cellco Partnership d/b/a Verizon Wireless ("Cellco") has compiled a series of additional exhibits in support of its proposal to construct a telecommunications facility on the 44-acre Rich Farm property at 445 Prospect Street, Woodstock, Connecticut (the "East Woodstock cell site"). These additional exhibits were compiled at the request of the Connecticut Siting Council ("Council") and relate to certain specific matters discussed at the Council's March 11, 2010 hearing. Cellco will seek to have each of these exhibits admitted into the Docket No. 397 record. The numbering of these exhibits follow sequentially, those exhibits previously admitted.

1. Exhibit No. 17 – This exhibit consists of a photograph of a new Cellco installation in Granby, Connecticut. In Granby, Cellco recently extended the height of an existing 64-foot grain silo by 20 feet, to an overall height of 84 feet. Cellco installed its antennas at a centerline height of 74'-6" inside the top of the silo structure. AT&T antennas are located at the 64'-6" level inside the silo.

- 2. Exhibit No. 18 This exhibit contains a copy of the Conveyance of Development Rights for the Kuper property located immediately north of the Rich Farm. This exhibit includes a map showing the Kuper property, and the area in the southwest corner of the parcel marked "Lands Retained By Arthur & Phyllis Kuper". This 2.52 acre portion of the Kuper property is not part of the land whose development rights were sold to the State of Connecticut.
- 3. Exhibit No. 19 This exhibit is a coverage map, showing the proposed coverage along portions of Route 169 and Route 197 from Cellco's existing cell sites and proposed East Woodstock cell site at cellular frequencies.
- 4. <u>Exhibit No. 20</u> This exhibit is a preliminary wetlands delineation map for the southeast portion of the Rich Farm. The "Proposed Alt. Tower Location" identified on this exhibit is the same location as Potential Alternate Site B shown on <u>Exhibit 22</u> below.
- 5. Exhibit No. 21 This exhibit includes a visual assessment memorandum consisting of a series of photosimulations showing the Alternative Site Location near the Rich Farm barn buildings depicting two alternative stealth tower structures; a 150-foot farm silo; a 150-foot windmill structure; and a viewshed map for the Alternate Site Locations. Although Cellco would maintain a 140-foot antenna centerline at this location to meet its coverage objectives, an additional ten feet would be necessary to develop these stealth alternatives. The cost for these alternative structures are estimated to be \$750,000 for the farm silo and \$60,000 to 75,000 for the windmill structure. A tower at any of the alternative site locations would cost Cellco approximately \$50,000.
- 6. Exhibit No. 22 This exhibit includes an assessment memorandum of four (4) alternative site locations on the Rich Farm. This memo concludes that Site B is an alternative worthy of further review by the Council. Also included in this exhibit is a series of

photosimulations and associated viewshed map, as well as a preliminary lease exhibit and access route for the "Potential Alternate Site B".

7. <u>Exhibit No. 23</u> – This exhibit contains existing and proposed coverage plots for a 160-foot tower at Alternate Site B at cellular and PCS frequencies.

#### CONVEYANCE OF DEVELOPMENT RIGHTS

TO ALL PEOPLE TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE THAT ARTHUR KUPER and PHYLLIS KUPER, both of the Town of Woodstock, County of Windham, and State of Connecticut, hereinafter referred to as Grantors, for the consideration of TWO HUNDRED FIFTY THREE THOUSAND FIVE HUNDRED SEVENTY-FIVE and 00/100 (\$253,575.00) DOLLARS and other good and valuable considerations, received to their full satisfaction of the STATE OF CONNECTICUT, a sovereign, do give, grant, bargain, sell and confirm in perpetuity unto the said STATE OF CONNECTICUT, its successors and assigns forever, hereinafter referred to as Grantee, DEVELOPMENT RIGHTS, as such term is defined in Chapter 422a of the Connecticut General Statutes, more specifically Section 22-26bb(d) of the Connecticut General Statutes, in and to the following described agricultural land:

ALL THOSE certain pieces or parcels of land situated in the Town of Woodstock, County of Windham, and State of Connecticut, as follows:

See Schedule "A" annexed hereto and made a part hereof, which land is hereinafter referred to as the "Premises".

The rights herein conveyed are conveyed subject to and in accordance with the purposes and provisions of Chapter 422a of the Connecticut General Statutes, (hereinafter referred to as Chapter 422a).

Said DEVELOPMENT RIGHTS are conveyed subject to the matters on Schedule B attached hereto and made a part hereof.

Grantors acknowledge that it is the purpose and intent of Chapter 422a of the Connecticut General Statutes that agricultural land be maintained and preserved for farming and food production purposes and that such maintenance and preservation is necessary in order to insure the well-being of the people of the State of Connecticut now and in the future. Grantors acknowledge that the parties intend by this conveyance to prohibit the subdivision or development of the Premises for residential, commercial and/or industrial purposes on the Premises. This conveyance is made in accordance with the following terms and conditions:

- A. The Grantors covenant for themselves, their legal representatives, heirs, successors and assigns, that the Premises will, at all times, be held, used, and conveyed in their entirety and subject to, and not used in violation of, the following restrictions as said restrictions may be limited or affected by the provisions of Paragraph B below.
  - (1) The fee simple owner of the above described land shall not subdivide, develop, construct on, sell, lease or otherwise improve the Premises for uses that result in rendering the Premises no longer agricultural land;
  - (2) No use shall be made of the Premises, and no activity shall be permitted or conducted thereon which is or may be inconsistent with the perpetual protection and preservation of the land as agricultural land. No activity shall be carried on which is detrimental to the actual or

potential agricultural use of the Premises, or detrimental to soil conservation, or to good agricultural management practices;

- (3) Said development rights are considered and deemed dedicated to the State of Connecticut in perpetuity in accordance with Chapter 422a of the Connecticut General Statutes.
- B. Notwithstanding any provision of this instrument to the contrary, the Grantors for themselves, their legal representatives, successors, heirs, and assigns, hereby reserve all other customary rights and privileges of ownership including:
  - (1) the right to privacy;
  - (2) the right to carry out regular agricultural practices;
  - (3) the right to conduct the uses defined in Subsection(q) of Section 1-1 of the Connecticut General Statutes;
  - (4) the right of the fee owner of the premises to develop, construct on, sell the Premises in its entirety, lease or otherwise improve the Premises to preserve, maintain, operated or continue the Premises as agricultural land, including but not limited to construction thereon of (a) residences for persons directly incidental to farm operation and buildings for animals; (b) roadside stands and farm markets for sale to the consumer of food products and ornamental plants; (c) facilities for the storage of

equipment and products or processing thereof; (d) such other improvements, activities and uses thereon as may be directly or incidentally related to the operation of the agricultural enterprise, as long as the acreage and productivity of arable land for crops is not materially decreased and due consideration is given to the impact of any decrease in acreage or productivity of such arable land upon the total farm operation, provided, however, that new construction of or modification of an existing farm building necessary to the operation of a farm on prime farmland, as such term is defined by the United States Department of Agriculture, on the Premises, shall be limited to not more than five percent of the total of such prime farmland.

- (5) the rights of the fee owner of the Premises to provide for the extraction of gravel or like natural elements for purposes directly or incidentally related to the operation of the agricultural enterprise or;
- (6) the rights of the fee owner of the Premises to the existing water and mineral rights, exclusive of gravel, except that no extraction or removal of minerals by any surface mining method shall be permitted. Furthermore, retention of such mineral rights is made subject to the purpose sand provisions of Paragraph A (2), above.

Grantors, their successors, heirs and assigns, shall notify the Commissioner of Agriculture of any proposed sub-surface extraction or removal of minerals or construction on the

The Commissioner of Agriculture may enter upon the Premises, at all reasonable times, for the purpose of determining compliance with the provisions of this conveyance and of Chapter 422a.

Grantee, its successors and assigns, shall have the right to enforce the restrictions contained in this conveyance by appropriate legal proceedings, including but not limited to, the right to require the restoration of the property to its condition at the time of the conveyance, as modified by any uses and alterations permitted under this conveyance.

TO HAVE AND TO HOLD the above granted DEVELOPMENT RIGHTS, unto it, the said Grantee, its successors and assigns forever, to its and their own proper use and behoof.

AND ALSO, the said Grantors do for themselves, their heirs, executors, successors, assigns and administrators, covenant with the said Grantee, its successors and assigns, that at and until the ensealing of these presents, it is well seized of the Premises, as a good indefeasible estate in FEE SIMPLE: and has good right to bargain and sell said DEVELOPMENT RIGHTS in manner and form as above written; and that the same is free from all encumbrances whatsoever, except as hereinbefore mentioned.

AND FURTHERMORE, the said Grantors, do by these presents bind themselves and their heirs, successors, assigns, executors and administrators forever to WARRANT AND DEFEND the above
