TO FIELD REVIEW FROM I-95

Follow I-95 to Exit 18, Sherwood Island Connector

At end of ramp, follow Connector north towards Westport (away from Sherwood Island S.P.)

Take first right onto Nyala Farm Road (follow sign to train station)

Turn right onto Greens Farms Road.

Bear right at Y intersection onto Beachside Ave-follow over I-95 overpass.

Travel ¼ mile and take sharp left onto New Creek Road before bridge over marsh.

6 is on left- park along road on right or on side street across from site.

TO TOWN HALL FROM SITE

If you parked on right side of road - proceed straight - no U turn.

Follow New Creek Road past train station and I-95.

Turn left onto Greens Farms Road and follow to Nyala Farm Road.

Turn left onto Nyala Farm Road.

Turn right onto Sherwood Island Connector.

Turn left onto Route 1 and follow approx. 1.25 miles

Turn right onto Myrtle Avenue at traffic light– after Getty gas station and old white church.

Follow to 110 Myrtle Ave on right – park to rear of Town Hall.

TO TOWN HALL FROM I-95

Follow I-95 to Exit 18, Sherwood Island Connector

At end of ramp, follow Connector north towards Westport (away from Sherwood Island S.P.)

Turn left onto Route 1 and follow approx. 1.25 miles

Turn right onto Myrtle Avenue at traffic light– after Getty gas station and old white church.

Town Hall is on right – take first driveway and park in rear.

TO TOWN HALL FROM MERRITT PARKWAY


Take Exit 42 and follow Route 57 south
Follow Route 57 to Y intersection- bear left onto Main Street. Route 57 goes right. (Bogey's is on corner)
At second light, take left onto Avery Place.
At stop sign, take left.

From town hall, turn right.

Take right onto Main Street and proceed 0.25 mile.

Bogey's is on left at traffic light, corner of Main and Canal.
