Pursuant to Regulations of Connecticut State Agencies §16-50j-77(b), your request to install three CommScope model SBNHH-1D65A antennas instead of model APX16DWV-16DWVS-C-A20 antennas is hereby approved.

This approval applies only to the D&M Plan revision dated September 14, 2015. Any significant changes to the D&M Plan require advance Council notification and approval.

On behalf of North Atlantic Towers, II ("NAT"), Phoenix Partnership LLC ("Phoenix") hereby requests the following change to the approved D&M plans dated September 20, 2012. T-Mobile will be installing three CommScope antenna model SBNHH-1D65A instead of the previously approved antenna model APX16DWV-16DWVS-C-A20. The new antenna is slightly smaller in length and width but larger in depth than the approved antenna.

- **SBNHH-1D65A** – Depth 7.1"x Length 55.6"x Width 11.9" Weight- 33.5 lbs
- **APX16DWV-16DWVS-C-A20** - Length 55.9"x Width 13" x 3.15" Depth Weight 40.7 lbs.
