Re: DOCKET NO. 401 – American Towers LLC Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located at 208 Valley Road, New Canaan, Connecticut.

Transfer of Certificate - Corrective Action and Request for Extension of Time

Dear Attorney Bachman:

The Council transferred the Certificate in the above referenced Docket to Florida Tower Partners, LLC d/b/a North Atlantic Towers ("North Atlantic Towers") on February 20, 2015. Subsequently, American Towers LLC acquired many of North Atlantic Towers' wireless facilities in Connecticut and filed to transfer the certificates for most of the North Atlantic Tower sites within the Council's jurisdiction. The above referenced site was inadvertently included in that bulk certificate transfer. This site is still owned by Florida Tower Partners, LLC d/b/a North Atlantic Towers, and was not acquired by American Towers. North Atlantic Towers has brought this issue to American Towers' attention and they have agreed that the certificate transfer should be corrected.

Florida Tower Partners, LLC d/b/a North Atlantic Towers requests that the Council transfer the Certificate back into its entity name.

Further, North Atlantic Towers requests an extension of time to complete construction of this project. On October 15, 2014, the Council granted a one year extension of time to Phoenix Partnership to complete construction by August 3, 2015. North Atlantic Towers requests that this completion date be extended by one year.
