

THE APPLICANT'S SUPPLEMENTAL PROPOSED FINDINGS OF FACT

Pursuant to § 16-50j-31 of the Regulations of Connecticut State Agencies, T-Mobile Northeast LLC ("T-Mobile") submits these supplemental proposed findings of fact.

83. On November 2, 2010 T-Mobile filed a motion to reopen the evidentiary proceedings for the limited purpose of considering the reconfiguration of the proposed telecommunication facility to accommodate a third carrier, and to allow Cingular Wireless PCS, LLC ("AT&T") to intervene. (*T-Mobile Motion to Reopen dated November 2, 2010*).

84. On November 15, 2010 AT&T filed for intervenor status. (*AT&T Request for Intervention dated November 15, 2010*).

85. On November 18, 2010 the Council approved T-Mobile's request to reopen the evidentiary proceeding, and AT&T's request to intervene. (*December 8, 2011 1:00 p.m. Transcript ["12/8/11 Tr."] p. 4*).

86. On August 25, 2011 AT&T withdrew its participation as an intervenor in this docket. (*AT&T letter dated August 25, 2011*).

87. T-Mobile worked with the landowner to redesign the site in a way that accommodated the carrier interest, and addressed the landowner's design concerns. (12/8/11 Tr. pgs. 13, 15).

88. T-Mobile submitted revised design plans on December 1, 2011. (*Supplemental Pre-filed Testimony of Carlo Centore, P.E. ["Supplemental Centore Testimony"]*, Attachment A).

89. The differences between the original and revised facility design are captured in the chart provided in the Supplemental Centore testimony.

	ORIGINAL DESIGN	REVISED DESIGN
Carrier Co-location	T-Mobile, Verizon and AT&T	T-Mobile and Verizon
Compound Area	1,250 SF	1,250 SF
Tree removal	3 trees	5 trees
Screening	Existing natural vegetative and topographical screening	The addition of a double row of 6-8 feet tall arborvitae trees along the east side of the compound to further screen the site.
Visibility in immediate area	Verizon's shelter would be visible above the perimeter fence	Top of Verizon's shelter (and any appurtenant equipment) will not be seen from the nearest down gradient residential structure on the Property.

90. The Facility would remain the same height (120 ft). T-Mobile would occupy one level (at 117 ft. AGL) and Verizon would occupy two levels (106 ft. and 96 ft. AGL) in the Revised Design. (*Supplemental Centore Testimony, pg. 2*).

91. The Revised Design would have no impact on the proposed clearing and grading requirements, NEPA results or initial RF coverage. (*Supplemental Centore Testimony, pg. 3; 12/8/11 Tr. pgs. 9-10*).

92. The tower in the Revised Design would be narrower than that in the Original Design, and therefore there would be some improvement to the near view visibility. (*Supplemental Centore Testimony, pg. 9*)

93. The Revised Design has been approved by the landowner and Verizon. (*12/8/11 Tr. pgs. 17, 19*).

94. The Revised Design would have no impact on Verizon's proposed coverage. (*12/8/11 Tr. pg. 39*).

95. As a result of the landowner input, T-Mobile has not designed the Facility to be extendable, but could do so if requested by the Council. (*12/8/11 Tr. pgs. 28,30*).
