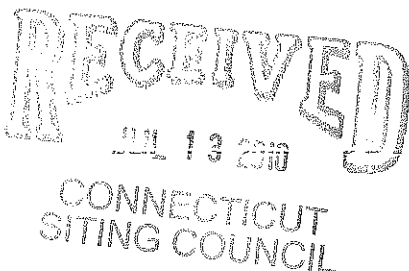

Dear Mr. Caruso:

My office was recently contacted by Fred Thaler and other Cornwall residents regarding Cellco's proposal to the Connecticut Siting Council ("Council") to construct a cellular telephone tower in Cornwall.

I believe the location proposed by Cellco is poorly sited - - in close proximity to a residential neighborhood - - and could adversely affect the health of the surrounding community. This site also raises concerns because it abuts the Housatonic State Forest. In light of these important objections, I ask that Cellco reconsider its decision.

I will ask that the Council review these important issues and follow its statutory mandate to consider alternative sites that would limit any impact on the citizens of Cornwall and Connecticut and the health of the surrounding community.
