Directions to Site

Site is located at 100 Marsh Hill Road in Orange, Connecticut.

From Hartford, New Britain, Meriden, Enfield, Wolcott, Stonington

- Take I-95 southbound to Exit 41 (Marsh Hill Road)
- At end of exit ramp, turn right and go approximately .2 mile to parking lot of Christmas Tree store
- In the parking lot, look for representatives of UI — Council will assemble in parking lot and then travel in a van or bus provided by UI to the actual site, which is part of a larger construction site for UI's Operations Center

From Milford and Fairfield:

- Take I-95 northbound to Exit 41 (Marsh Hill Road)
- Turn left at end of exit ramp and travel north to parking lot of Christmas Tree store
- In the parking lot, look for representatives of UI — Council will assemble in parking lot and then travel in a van or bus provided by UI to the actual site, which is part of a larger construction site for UI's Operations Center

To Hearing from Site

Hearing will be in the High Plains Community Center gymnasium at 525 Orange Center Road, Orange, Connecticut.

- From Christmas Tree shop parking lot, turn right onto Marsh Hill Road
- At first stop light, turn left onto Route 1 – Boston Post Road
- Follow Route 1 to intersection with Route 152 (Orange Center Road) and turn right
- High Plains Community Center will be approximately 1.1 miles on right, just after the 345 kV overhead transmission lines

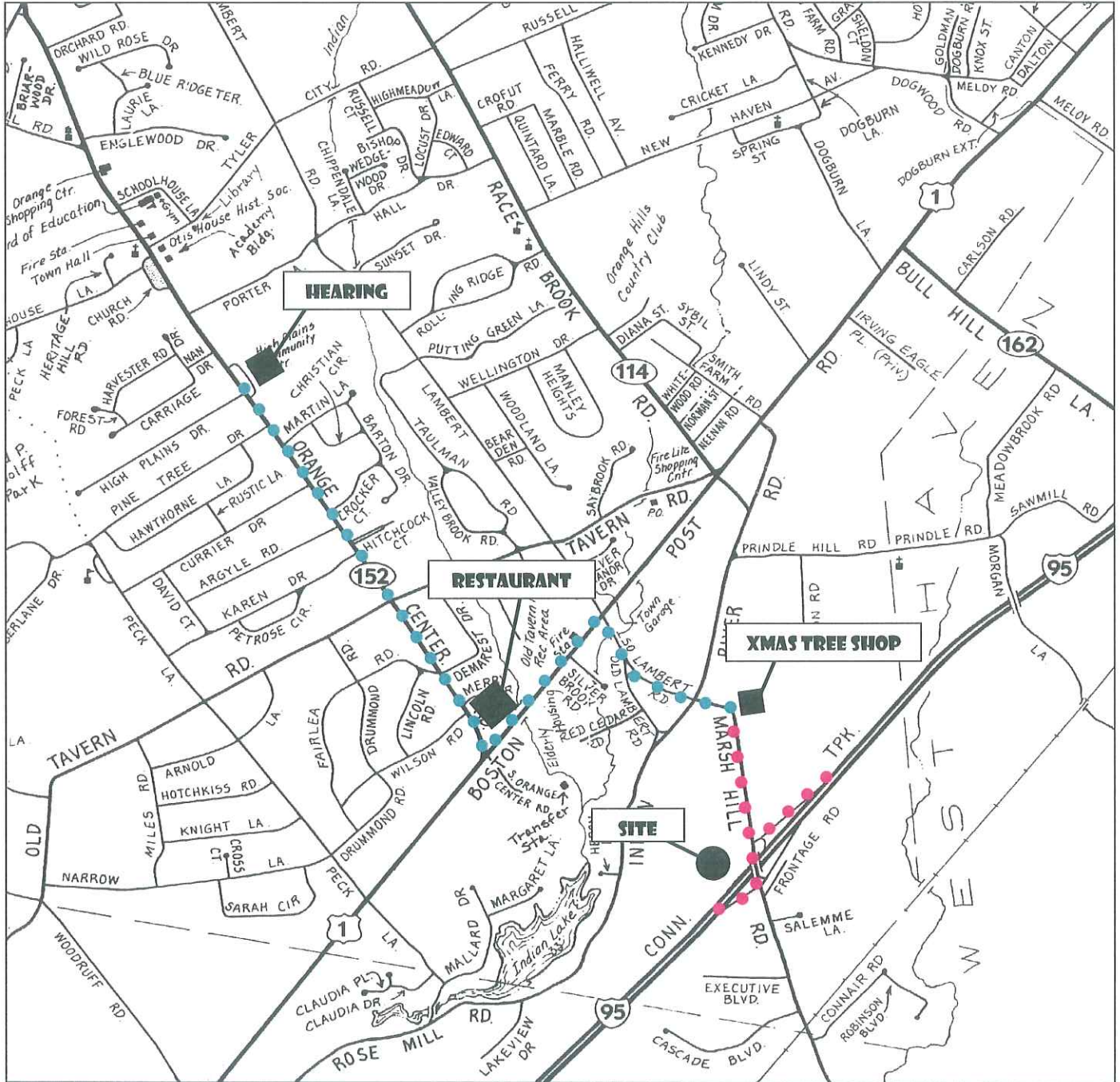
To Restaurant
