MOTION IN LIMINE

Party Thomas H. Sirman moves, pursuant to the Uniform Administrative Procedure Act, General Statutes §§ 4-166 et seq., General Statutes §§ 16-50g et seq., Regs., Conn. State Agencies §§ 16-50j-1 et seq. and applicable law to preclude the introduction of any testimony from Daniel L. Goulet at the public hearing on the captioned matter.

In the scheduling order dated April 4, 2011 on Docket No. 408, a copy of which is attached hereto, the parties were instructed to pre-file all testimony and exhibits with the Connecticut Siting Council by May 9, 2011. Applicant, New Cingular Wireless PCS, LLC has filed no objection to this scheduling order. Applicant, New Cingular Wireless PCS, LLC, did pre-file an "update to witness list" identifying Mr. Goulet, but has not pre-filed his direct testimony.

As described by the Siting Council, the purpose of the public hearing is to "provide the
