RE: **DOCKET NO. 408** - New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located at 95 Balance Rock Road, Hartland, Connecticut.

During the hearing held on January 13, 2011 in the Town of Hartland for the above-referenced docket, the Connecticut Siting Council (Council) ruled on the following matters:

1. **Heike M. Krauland's Request for Party Status dated January 5, 2011:** Heike M. Krauland's Request for Party Status was granted.
2. **Thomas Sirman's Request for the Right to Inspect the Property at Balance Rock Road dated January 13, 2011:** Thomas Sirman's Request for the Right to Inspect the Property at Balance Rock Road was denied.
3. **Thomas Sirman's Motion in Limine dated January 13, 2011:** Thomas Sirman withdrew his Motion in Limine on the condition that AT&T submits pre-filed testimony and resumes for each of its witnesses on or before January 27, 2011. The Council requested that the pre-filed testimony include specific witness expertise in wildlife biology.
4. **AT&T's Objection to Thomas Sirman's Request for Administrative Notice Items dated January 13, 2011:** AT&T's Objection to Thomas Sirman's Request for Administrative Notice was denied.
5. **Thomas Sirman's Petition to Intervene Under the Connecticut Environmental Protection Act (CEPA) dated January 13, 2011:** Thomas Sirman's Petition to Intervene Under CEPA was granted.

The continuation of the evidentiary portion of this hearing shall be held on Tuesday, March 1, 2011 beginning at 11:00 a.m. in Hearing Room Three, Ten Franklin Square, New Britain, Connecticut.

The Council requests that the parties and intervenors issue pre-hearing interrogatories to other parties and intervenors on or before February 8, 2011. Responses to interrogatories and any additional pre-filed testimony and exhibits are requested to be filed with the Council and other parties and intervenors on or before February 22, 2011.
