DIRECTIONS TO FIELD REVIEW - 95 Balance Rock Road, Hartland- 2:00 pm

Via Interstate 91 in Hartford Area

Follow I-91 to Exit 40, Route 20 west.
Follow Route 20 west into East Hartland village.
After village, proceed 0.8 miles to Balance Rock Road on left.
Follow to end, site is on right.

Via Interstate 84 from New Britain area

Follow I-84 to Exit 39, Route 4 west.
Follow Route 4 west through Unionville.
Go straight onto Route 179 north as Route 4 west turns left at traffic light.
Follow Route 179 through Collinsville and past Route 44.
Follow Route 179 into East Hartland village.
Turn left onto Route 20 west.
Proceed 0.8 miles to Balance Rock Road on left.
Follow to end, site is on right.

Via Route 8 in Waterbury and Winsted areas

Follow Route 8 to Route 44 east in Winsted.
Follow Route 44 east to Route 318 east.
Follow Route 318 east to Route 179 north.
Follow Route 179 north into East Hartland village.
Turn left onto Route 20 west.
Proceed 0.8 miles to Balance Rock Road on left.
Follow to end, site is on right.

TO HEARING LOCATION - East Hartland Fire Department, 34 Route 179, East Hartland – 3 p.m.

From Site

Return to Route 20 and turn right.

Bear right onto Route 179 south.

Go 0.1 mile and turn left into first driveway - Town Hall driveway - park behind Town Hall - walk between town hall and school to Fire Dept. building.

(Fire Dept. and school have a common driveway and it may be blocked).

Via Interstate 91 in Hartford Area

Follow I-91 to Exit 40, Route 20 west.
Follow Route 20 west into East Hartland.
Turn left onto Route 179 south.
Go 0.1 mile and turn left into Fire Dept. parking lot (Fire Dept and school share driveway and it may be blocked).

Via Interstate 84 from New Britain area

Follow I-84 to Exit 39, Route 4 west.
Follow Route 4 west through Unionville.
Go straight onto Route 179 north as Route 4 west turns left at traffic light.
Follow Route 179 through Collinsville and past Route 44.
Follow Route 179 north into East Hartland
Fire Department is on right in school/town hall complex.
