RE: **DOCKET NO. 409A** - New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located at 8 Barnes Road, Canaan (Falls Village), Connecticut. Reopening of this docket pursuant to Connecticut General Statutes § 4-181a(b) limited to Council consideration of changed conditions, revised tower site location and modified facility.

The Connecticut Siting Council has scheduled a field review for this docket for Tuesday, April 30, 2013, beginning at 2:00 p.m. Council Members will meet at the CITGO gas station at the junction of Route 63 and Route 7 in Canaan. Council Member directions are enclosed.

The existing driveway on the property is steep and rough, accessible only by 4x4 vehicle or by foot. Council Members will be shuttled to the site via a 4x4 vehicle up the existing driveway to the cabin. From the cabin, the field review will require a 0.4 mile walk (one way) on a rough logging road with some uphill areas. Appropriate foot wear is strongly recommended.

A public hearing is scheduled for Tuesday, April 30, 2013, beginning at 3:30 p.m., and continued at 7:00 p.m., in the All Purpose Room at the Lee H. Kellogg School, 47 Main Street, Falls Village, Connecticut. **Please Note: Access to the school grounds is restricted until school is out of session. Do not enter school property until after 3:00 p.m.**

DIRECTIONS TO FIELD REVIEW – 8 Barnes Road, Falls Village

From Waterbury

Travel via Route 8 North to Exit 44 (Route 4 and 202)

At end of ramp, go straight to get on Route 4 west.

Take left onto Route 4 West

Follow Route 4 West to Route 63 North in Goshen (traffic circle).

Bear right onto Route 63 North at traffic circle.

Follow Route 63 North. After passing Route 126, Route 63 enters South Canaan village.

CITGO/Crossroad Deli is just past South Canaan Meeting House on the left. Route 7 is beyond CITGO.

Council Members will be shuttled to the site.

From Hartford/New Britain

Follow Interstate 84 West to Exit 39 for Route 4 West.

Follow Route 4 West past Torrington and into Goshen.

Bear right onto Route 63 North at traffic circle.

Follow Route 63 North. After passing Route 126, Route 63 enters South Canaan village.

CITGO/Crossroad Deli is just past South Canaan Meeting House on the left. Route 7 is beyond CITGO.

Council Members will be shuttled to the site.

To Hearing Location from the Proposed Site

From the picnic table side of CITGO/ Crossroad Deli, turn left onto Route 7 south.

Follow Route 7 to Route 126 west

Turn right onto Route 126 west/Main Street

The school is on the left. **Entry to school grounds is prohibited prior to 3:00 p.m.**

From Hartford/Waterbury

Follow directions to field review above to Route 126.

Turn left onto Route 126 west. School is on left, past Route 7 intersection.

Entry to school grounds is prohibited prior to 3:00 p.m.

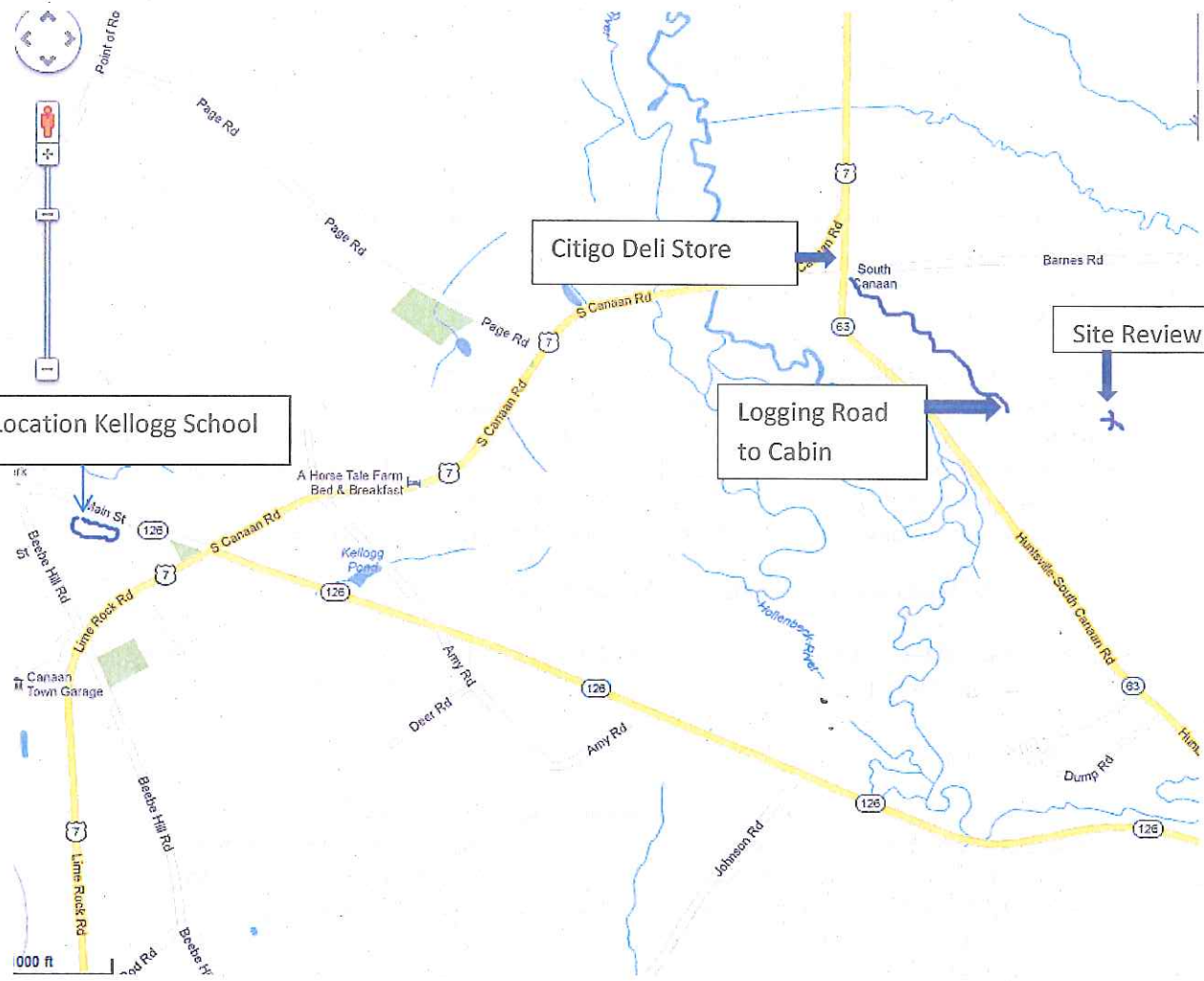

Directions

Zia Maria's is on right, with parking lot across from "Steppin Stone".
