RE: **DOCKET NO. 409A** - New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications facility located at 8 Barnes Road, Canaan (Falls Village), Connecticut. Reopening of this docket pursuant to Connecticut General Statutes § 4-181a(b) limited to Council consideration of changed conditions, revised tower site location and modified facility.

On July 25, 2013, AT&T submitted to the Connecticut Siting Council (Council) and the service list a Request for the Council to take Administrative Notice of a letter from the State Historic Preservation Office dated June 28, 2013. The Council requests parties and intervenors to submit any comments on or objections to this request before the close of business on August 1, 2013.

Also on July 25, 2013, AT&T submitted to the Council and the service list a Hearing Transcript Errata Sheet for the June 11, 2013 public hearing. The party, Marc Rosen and Susan Pinsky, also submitted a correction to page 30 of the June 11, 2013 public hearing transcript, which is incorporated in the AT&T errata sheet, as part of their post-hearing submission dated July 23, 2013.

As indicated in an e-mail to the service list from Carriann Mulcahy dated July 3, 2013 (a copy of which is attached), a recording of the public hearing held on June 11, 2013, in accordance with the provisions of Section 4-177(d) of the Uniform Administrative Procedures Act, is and has been available since that date, and was and will be provided upon request. The Council requests parties and intervenors to submit any additional comments on or additional corrections to the public hearing transcript errata sheet for the June 11, 2013 public hearing before the close of business on August 1, 2013.

These matters, in addition to the Council's Draft Findings of Fact, will be on the Council meeting agenda scheduled for August 8, 2013.
