We are writing with respect to Docket No. 409A to ask that the Siting Council deny the "New Cingular Wireless (AT&T)" application to build a cell tower at 8 Barnes Road in Falls Village/Canaan.


We refer to our pre-filed testimony of May 5, 2013 (and our May 8th responses to Applicant's Interrogatories of May 7), and to our pre-filed testimony for the Siting Council's hearing on June 11, 2013, and additional submissions, including an excerpt from the Town of Canaan/Falls Village mission statement (from the town's website), and a letter from an architectural historian.


We remain deeply skeptical of any data and justifications that the Applicant provides with respect to the easement and proposed access road. The Applicant was clearly aware that the proposed access road impinged on our property, but only made a correction when challenged. Similarly, the Applicant continues to assume the right to make unilateral and substantial changes to the course of the easement. Since we are not parties to the easement, these changes do not affect our property rights, but they indicate a disregard for the rights of others.

We also still believe there is reason to doubt the safety of the proposed access road, which will have steep slopes at critical points.

Finally, we would like to point out that there are errors in the transcript of the June 11th hearing, not only typos or misheard words, but in some instances, misattributions of statements. For example, at the top of page 30, the first paragraph is credited to Mr. Perkins instead of Mr. Rosen: "Okay..." We have not printed out and proofed the whole transcript, but there are other instances.




