I am a member of the Town of Canaan Inland Wetlands/Conservation Commission that is a party in Docket 409 before the Connecticut Siting Council.


On the morning of Friday July 15, 2011 at about 10:15 a.m., I telephoned Linda Roberts, Executive Director of the Connecticut Siting Council to confirm the filing date for final filings on Docket 409.

I reached Director Roberts who told me that the deadline was Monday, July 18.

She then told me she wanted to be sure about this, and put me on hold while she consulted the Council's legal staff.

After a pause, she picked up the phone again to speak with me and confirmed that final filings would "meet the deadline" if the filings were postmarked on Monday, July 18th.

Just after speaking with Director Roberts I made a notation in my own hand on a post-it note, which is a contemporaneous record of my conversation. It is attached here as "Exhibit A."
