**NEW CINGULAR WIRELESS PCS, LLC ("AT&T")
SUPPLEMENTAL SUBMISSION**

New Cingular Wireless PCS, LLC ("AT&T") respectfully submits the following information in response to the Siting Council's request at the April 20, 2011 hearing for information regarding the percentage of households that replaced their landline phones with wireless phones.

Based on a study by the U.S. Department of Health and Human Services¹, national estimates for the 12 month period from July 2009 through June 2010 indicate that the percentage of adults living in wireless-only households is 23.9%. Statistics for the State of Connecticut indicate this percentage at 13.6%. This represents an approximately eightfold increase in wireless-only households nationally over a six year period. Of note, the study reports that the prevalence of national wireless-only households nearly double the same statistic for landline only households which is at approximately 12.9% and declining.
