

LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about December 15, 2010, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications facility on a 0.267 acre parcel at 36 Ritch Avenue in Greenwich, Connecticut. The property is owned by 36 Ritch Avenue LLC. At this site, Cellco proposes to construct a 77-foot monopole tower disguised as a pine tree. Simulated branches will extend above the top of the tower to an overall height of 84 feet. Access to the site will extend from Ritch Avenue over a paved driveway a distance of approximately 270 feet to the cell site. A new 965 square-foot multi-carrier shelter would be located near the base of the tower. Cellco's radio equipment and a diesel-fueled back-up generator would be housed in a secured room inside the multi-carrier equipment shelter. The tower and equipment shelter will be shared by Cellco, AT&T, T-Mobile and the Greenwich Police Department. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.

On the day of the Siting Council public hearing on this proposal, Cellco will fly a balloon at the height of the proposed tower described above. Interested parties and residents of the Town of Greenwich are invited to review the Application on or after December 16, 2010, during normal business hours at any of the following offices:
