Pursuant to our recent telephone conversation, I thought it might be prudent for me to identify for you those existing tower sites that are currently subject to the "Project Sequoia Agreement" between Cellco Partnership d/b/a Verizon Wireless ("Cellco") and American Tower Corporation ("ATC"). Pursuant to the Project Sequoia Agreement, maintenance of the listed wireless facilities is the responsibility of ATC.
