TO FIELD REVIEW

Via Interstate 84 (Hartford)

Follow I-84 to Exit 69.
At end of ramp, turn right onto Route 74 east.
Follow Route 74 east to Route 44.
Turn left onto Route 44 east.
Turn left onto Route 198 north.
Turn right onto Route 171 east and travel approximately 5.5 miles.
Turn right onto East Quasset Road.
Turn right onto West Quasset Road and travel 0.3 miles.
Turn right at Quasset Hill Road (farm) – location of site.

Via Interstate 395 (Norwich)

Proceed on I-395 North.
Take Exit 97 and follow Route 44 west to Route 171 west.
Follow Route 171 1.2 miles past Route 169 and turn left onto East Quasset Road.
Turn right onto West Quasset Road and travel 0.3 miles.
Turn right at Quasset Hill Road (farm) – location of site.

TO TOWN HALL

From Site

From farm, turn left onto West Quasset Road.
Turn left onto East Quasset Road.
Turn right onto Route 171 (Somers Tpke) and follow to Route 169.
Turn left and follow Route 169 north 0.4 miles to Town Hall on right.

Via I-84 (Hartford)

Follow I-84 to Exit 69, Route 74.
Follow Route 74 east to Route 44 east.
Follow Route 44 east to Route 169 in Pomfret.
Follow Route 169 north to Town Hall on right after South Woodstock village.

Via Interstate 395 (Norwich)

Proceed on I-395 North.

Take Exit 97 and follow Route 44 west to Route 171 west.

Follow Route 171 west to Route 169 north.

Town Hall is on right after South Woodstock village.

To Dinner Location- Sherwood's

From Town Hall, turn left onto Route 169.

Bear left onto Route 171 east and follow for approx 1 mile to Little River Plaza on left (Sherwood's)

Turn left onto Route 169 south and follow past Route 171 to Route 44 west in Pomfret.

Follow Route 44 west to Route 74 west in Ashford.

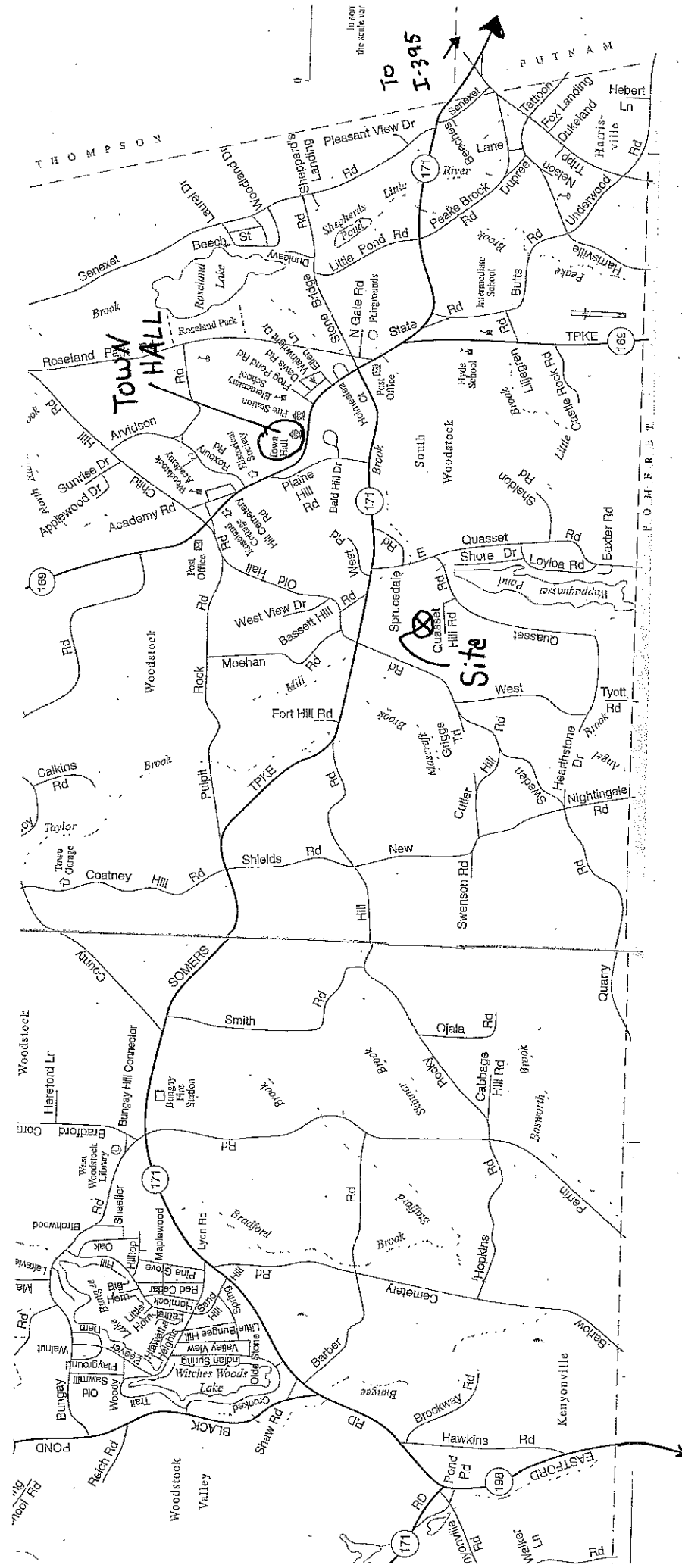
Follow Route 74 west to I-84.
