Directions to Site

Site is located off of Day Hill Road in Bloomfield, Connecticut.

From Hartford, New Britain, Meriden, Wolcott, Milford, Stamford, and Stonington:

- Take Interstate Highway 91 northbound to Exit 37 (Route 305; Bloomfield Avenue/Windsor Center).
- At end of exit ramp, turn left to travel westbound on Bloomfield Avenue (Route 305).
- Bloomfield Avenue will become Old Windsor Road in Bloomfield; follow to intersection with Route 187 (Blue Hills Avenue).
- At intersection, turn right onto Route 187.
- From Route 187, turn left onto Day Hill Road (at traffic light at entrance to The Hartford look for large brick structure on right; Day Hill Road will be first left after Woodland Avenue)
- Entrance to site will be on left from Day Hill Road <u>immediately</u> after crossing railroad tracks.

From Enfield:

- Take Interstate Highway 91 southbound to Exit 37 (Route 305; Bloomfield Avenue/Windsor Center).
- At end of exit ramp, turn right to travel westbound on Bloomfield Avenue (Route 305); then follow above directions.

From Norfolk

- Take Route 44 eastbound to intersection with Route 10 in Avon.
- At Route 10 intersection, turn left to travel northbound on Route 10 and follow to intersection with Route 185.
- At Route 185 intersection, turn right to travel eastbound and follow 185 to intersection with Route 178 Loeffler Road.
- Follow Route 178, which will become Mountain Avenue, to intersection with Route 189 (Tunxis Avenue).
- Turn left onto Route 189 and follow to traffic light at intersection with Day Hill Road; turn right onto Day Hill Road.
- Entrance to site will be on right immediately before crossing railroad tracks.

To Hearing from Site

Hearing will be at the Bloomfield Town Hall, 800 Bloomfield Avenue in Bloomfield.


- From the site, turn left onto Day Hill Road to travel westbound.
- At first traffic light, turn left onto Tunxis Avenue (Route 189).
- Follow Route 189 to center of Bloomfield and intersection with Route 178 (to right, 178 is Mountain Avenue; to left, 178 is Park Avenue)
- Turn left onto Route 178 Park Avenue.
- Turn right into first driveway, which will be parking lot for Town Hall.

To Restaurant

Dinner will be at Park Avenue Pizza and Restaurant, 772 Park Avenue in Bloomfield. Phone is 860-242-8503.

- From Town Hall, turn right onto Park Avenue.
- Restaurant will be approximately 550 feet (0.1 mile) on left in Northeast Plaza, near Dunkin Donuts.
