Notice is hereby given that the August 30, 2011 transcript of the hearing was received at the office of the Connecticut Siting Council on September 6, 2011.

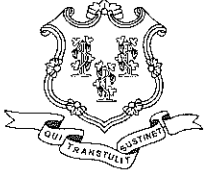

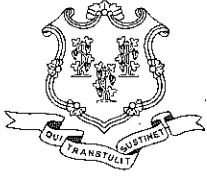
