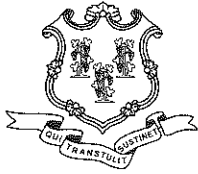

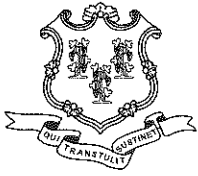
NOTICE OF HEARING CANCELLATION
