Notice is hereby given that the transcript of the October 11, 2011 hearing was received at the office of the Connecticut Siting Council on October 17, 2011.

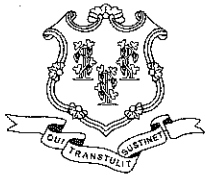
