The current deadline for the above mentioned docket is December 25, 2011. Due to the complex nature of this docket, the Connecticut Siting Council (Council) will need additional time to render a decision. Connecticut General Statute § 16-50p(a) provides, in part, that the Council's decision shall be rendered, "Not later than one hundred eighty days after the filing of an application for" a telecommunications tower "provided such time period may be extended by the Council by not more than one hundred eighty days with the consent of the applicant." The Council hereby requests such consent for an extension of the decision deadline in Docket No. 420 until February 23, 2012.

The applicant's consent to the requested extension of time shall have the effect of tolling the Federal Communications Commission (FCC) 150-day tower siting timeframe in accordance with Paragraph 49 of the FCC Declaratory Ruling issued on November 18, 2009 (FCC WT Docket No. 08-165).
