**1. Manner in which petitioner claims to be substantially and specifically affected:**

- Proposed site for cell tower is adjacent to homestead property.
- Inadequate information provided re terms of lease.

**2. Contention of the petitioner:**

No information provided re:

- Maintenance of Right of Way to proposed site for access to cell tower for installation, service and/or repair of cell tower;
- Maintenance of Right of Way for wear and tear caused by vehicles for installation and service using Right of Way for ingress and egress for reasons other than installation, repair and maintenance or removal/replacement of cell tower;
- Responsibility of Right of Way grantor for adequate insurance for vehicles used for installation, service and/or maintenance;
- Proposal for lease term, renewal and frequency of use of Right of Way to cell tower;
- Defined hazards of cell towers in proximity to residential use areas;
- Study information, if conducted, re de-valuation of properties adjacent to cell tower sites;
- Conditions and proposal for removal of cell tower at end of lease;
- Conditions for specific terms of length of use of Right of Way;
- Frequency of travel and access to cell tower based on empirical data;
- Aesthetic detriments to having cell tower adjacent to residential property;
- Compensation for use of Right of Way for ingress and egress disclosed.

- Answers to above questions.
- Formal acknowledgement of our opposition to cell tower on adjacent property based on inability to accept/reject proposal based on lack of information
