
#### Statement of Public Need

A facility at one of the Candidate Facility locations will provide communications service along Route 201 and other local roads as well as the homes in the surrounding area. A facility is needed by AT&T in conjunction with other existing and proposed facilities in the area to provide service to the public. Included are two plots which depict the "Existing Coverage" provided by AT&T's existing facilities in this area and coverage from the Candidate Facility Locations predicted with existing coverage from nearby sites. Additionally, a chart containing information concerning surrounding existing and proposed wireless communications sites in the greater surrounding area of the proposed facility is also included. No existing or other proposed wireless sites will serve the area of need. As demonstrated by these materials, a new facility is required for AT&T to serve the public reliably in this area.

## ATTACHMENT 2

#### Site Search Summary

Analysis of the communications towers located within 4 miles of the search area indicated that none of these towers would provide adequate coverage to the area targeted for service by the proposed North Stonington Facility. There are no existing or approved structures within the search area adequate to meet the coverage requirements of the proposed Facility.

SBA and AT&T investigated several locations where the construction of a new tower might be feasible. The description of the individual sites investigated is set forth below. Where applicable, the reason for eliminating the property is also included. Following these descriptions is a map indicating the location of all sites investigated.
