### **TO FIELD REVIEW**

#### **Via Interstate 84 (Waterbury)**

Follow I-84 to Route 8 South.  
Take Exit 9 for Merritt Parkway south.  
Follow directions from Merritt Parkway below.

#### **Via Interstate 95 from New Haven and Milford areas**

Follow I-95 to Exit 38 - Milford Connector.  
Follow Connector to Merritt Parkway south.  
Follow directions from Merritt Parkway below.

#### **Via Interstate 95 from Bridgeport - Stratford areas**

Follow I-95 to Route 8 north.  
Bear left onto Route 25 north.  
Take Merritt Parkway south exit and follow directions from Merritt Parkway below.

#### **From Merritt Parkway**

Take Exit 48 and follow Route 111 north (right hand turn if you were heading Merritt Parkway southbound)  
Take first right onto Edison Road. Police Station is on right.

### **TO Trumbull Town Hall (Hearing)**

#### **From Site**

From Police Station parking lot, turn left onto Edison Road.  
Take right onto Main Street (Route 111) and follow to second light.  
At second light, turn right onto Quality Street.  
Take left into parking area for town hall (town hall to left).

#### **From Merritt Parkway**

Take Exit 48 and follow Route 111 north.  
At third light, turn right onto Quality Street.  
Take left into parking area for town hall (town hall to left).
