5. Are fence privacy slats and/or landscaping proposed for the site? (refer to Council Finding of Fact 60)
6. Please submit a power density analysis that accounts for all tower users/equipment.
7. Please submit a schedule that includes construction of the tower, installation of T-Mobile's and Cellco's equipment, installation of the Town's equipment and removal of the existing Town tower.
