Directions to Site

Site is located at 655 Bassett Road in Watertown, Connecticut.

From Hartford, New Britain, Enfield, Meriden, Wolcott, Milford, Stamford, and Stonington:

- Take Route 8 northbound to Exit 37 (Route 262 Watertown).
- At end of exit ramp, turn left onto Route 262, which is Bridge Road at this location.
- Follow 262 to intersection of Route 6 (Thomaston Road) Bridge Street will become Buckingham Street along the way.
- At intersection with Route 6, continue straight across onto Fern Hill Road.
- Follow Fern Hill Road, which will become Smith Pond Road, to stop sign at intersection with Linkfield Road (there will be no street sign for Linkfield; but there will be a sign for Smith Pond Road)
- Turn right onto Linkfield Road and follow to stop sign at T-intersection at end of Linkfield.
- Site is off of dirt road directly ahead.

From Norfolk

- Take Route 8 southbound to Exit 37 (Route 262 Watertown).
- At end of exit ramp, turn right onto Echo Lake Road and follow to stop sign at T-intersection this will be Buckingham Street (Route 262).
- Turn right onto Route 262 and follow to intersection with Route 6.
- At intersection of Route 6 (Thomaston Road), continue straight across onto Fern Hill Road.
- Follow Fern Hill Road, which will become Smith Pond Road, to stop sign at intersection with Linkfield Road (there will be no street sign for Linkfield; but there will be a sign for Smith Pond Road)
- Turn right onto Linkfield Road and follow to stop sign at T-intersection at end of Linkfield.
- Site is off of dirt road directly ahead.

To Hearing from Site

Hearing will be at the Watertown High School Auditorium, 324 French Street in Watertown.


- From the site, turn right onto Bassett Road to travel westbound.
- Follow Bassett Road to stop sign at intersection with Route 63 (Litchfield Road at this location, but no street sign small pond directly across street).
- Turn left onto Route 63 and follow through center of Watertown, crossing Route 6 (Litchfield Road will become Main Street when you cross Route 6).
- From Route 63, turn left at light onto French Street cemetery will be on left.
- High school entrance is at traffic light just beyond Watertown Police Department.

To Restaurant

Dinner will be at Nonna Lucia's, 1133 Main Street, Watertown (860/274-9019).

- From Watertown HS, turn left onto French Street, then left onto Main Street (Route 63);
- Restaurant will be a few blocks on the left (just past Pizza Hut, which will be on right) in front of Watertown Plaza.
