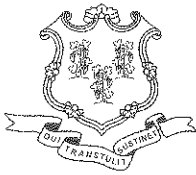
RE: **DOCKET NO. 424** - The Connecticut Light & Power Company application for a Certificate of Environmental Compatibility and Public Need for the Connecticut portion of the Interstate Reliability Project that traverses the municipalities of Lebanon, Columbia, Coventry, Mansfield, Chaplin, Hampton, Brooklyn, Pomfret, Killingly, Putnam, Thompson, and Windham, which consists of (a) new overhead 345-kV electric transmission lines and associated facilities extending between CL&P's Card Street Substation in the Town of Lebanon, Lake Road Switching Station in the Town of Killingly, and the Connecticut/Rhode Island border in the Town of Thompson; and (b) related additions at CL&P's existing Card Street Substation, Lake Road Switching Station, and Killingly Substation.

The Connecticut Siting Council (Council) announces that continued evidentiary hearing dates for this docket shall be held on Tuesday, August 28, 2012 and Thursday, August 30, 2012 beginning at 11 AM at the Council's Office, Hearing Room One, Ten Franklin Square, New Britain. Please make note of this change in venue. Parking is available in the Courthouse Garage.

During the evidentiary hearing held on the above-referenced docket on July 31, 2012, counsel for ISO-New England (ISO) indicated that ISO witness, Mr. Stephen Rourke, will be unavailable on Thursday, August 30, 2012. Therefore, ISO respectfully requested to be taken out of order and allowed to present their panel on Tuesday, August 28, 2012 for cross-examination by the Council and other parties and intervenors. After ISO's appearance, other party and intervenor appearances shall proceed in accordance with the order presented in the hearing program.

Any objections to taking ISO out of order should be filed with the Council and the service list for this docket on or before Wednesday, August 8, 2012.

Parties and intervenors are requested to file any additional interrogatories to the applicant or other parties and intervenors on or before August 14, 2012. Responses to interrogatories and any supplemental pre-filed testimony are requested to be filed on or before August 21, 2012.

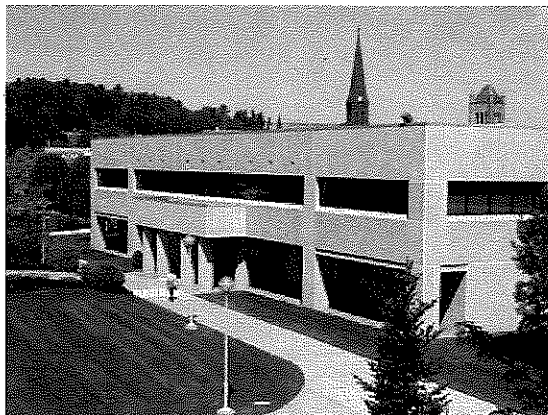

DIRECTIONS TO THE CSC

FROM NEW HAVEN AREA:

North on I-91 to Route 9 North New Britain/Berlin (Exit 22). Take the second New Britain exit, "Downtown New Britain," Exit 26. Turn left at light at end of exit. Follow street around curve. Turn right into 1st driveway. Garage will be facing you. DO NOT park in lot (it is reserved for far right building (Liberty Square)). You may park in the Linda A. Blogoslawski Garage. (The fee charged is \$2.50 an hour with a \$12.50 per day maximum). CSC is on other side of garage. Enter office building from courtyard side facing courthouse.

FROM NEW LONDON AREA:

Interstate 95 to Route 9 North (Exit 69). Take the second New Britain exit, "Downtown New Britain" (Exit 26). Turn left at light at end of exit. Follow street around curve. Turn right into 1st driveway. Garage will be facing you. DO NOT park in lot (it is reserved for far right building (Liberty Square)). You may park in the Linda A. Blogoslawski Garage. (The fee charged is \$2.50 an hour with a \$12.50 per day maximum). CSC is on other side of garage. Enter office building from courtyard side facing courthouse.

FROM NORWICH AREA:

Take Route 2 West (Exit 5-D) to Putnam Bridge in Glastonbury. After crossing Connecticut River, follow signs to 91 South. Continue on 91 South. Take Route 9 North (Berlin/New Britain - Exit 22). Take the second New Britain exit, "Downtown New Britain," Exit 26. Turn left at light at end of exit. Follow street around curve. Turn right into 1st driveway. Garage will be facing you. DO NOT park in lot (it is reserved for far right building (Liberty Square)). You may park in the Linda A. Blogoslawski Garage. (The fee charged is \$2.50 an hour with a \$12.50 per day maximum). CSC is on other side of garage. Enter office building from courtyard side facing courthouse.

FROM HARTFORD AREA, MASSACHUSETTS, ETC.

From I-91 South take I-84 West to Exit 39A. Take Route 9 South to Chestnut Street (Exit 27 left-lane exit). At the end of exit, turn right onto Chestnut Street, then left at first light (1/2 block) onto Columbus Boulevard. Turn right at the next light. Follow street around curve. Turn right into 1st driveway. Garage will be facing you. DO NOT park in lot (it is reserved for far right building (Liberty Square)). You may park in the Linda A. Blogoslawski Garage. (The fee charged is \$2.50 an hour with a \$12.50 per day maximum). CSC is on other side of garage. Enter office building from courtyard side facing courthouse.

FROM BRIDGEPORT AND WATERBURY AREA:

North on Route 8 to I-84 east bound to Exit 35 (Route 72 East). Continue on Route 72 East to "Route 71 to Main Street" Exit. Go right at light at top of the ramp; then at next light continue straight ahead onto Main Street. Turn left from left turn lane in middle of block into driveway between office buildings. You will see garage ahead on right. DO NOT park in lot (it is reserved for building on left (Liberty Square)). You may park in the Linda A. Blogoslawski Garage. (The fee charged is \$2.50 an hour with a \$12.50 per day maximum). CSC is on other side of garage. Enter office building from courtyard side facing courthouse.
