Dear Chairman Stein and Members of the Connecticut Siting Council:

On behalf of Message Center Management (“MCM”), please accept this letter regarding the captioned Facility for which the Siting Council issued a Certificate of Environmental Compatibility and Public Need in Docket 425.

Condition 7 of the Decision and Order dated January 21, 2012 required the approved facility to be fully constructed and providing wireless services within eighteen months from the date of the mailing of the Council’s Findings of Fact, Opinion, and Decision and Order. On October 17, 2013, the Council granted an extension of time for AT&T to make the facility operational by June 30, 2014.

Message Center Management (“MCM”) has commenced construction, the tower is in place and MCM and its vendors are working diligently on final camouflaging and compound installation in order to bring the facility on-air. We respectfully request a six (6) month extension to the end of December 2014 which should assure sufficient time for the tower to be fully completed and operational.
