TO FIELD REVIEW

From Interstate 95 in New Haven

Follow I-95 northbound to Exit 53.
At end of ramp, turn right under RR bridge and get in left lane.
Turn left onto Route 142 (traffic light).
Follow Route 142 west for approx. one mile.
Site is on right - driveway for AIR INC.

From Interstate 95 in Old Saybrook

Follow I-95 southbound to Exit 54, Cedar Street.
Take left onto Cedar Street and follow to Route 1.
Take right onto Route 1 and follow under RR bridge.
Immediately after RR bridge, turn left onto Route 142 west.
Follow Route 142 west for approx. one mile.
Site is on right - driveway for AIR INC.

To East Haven Site from Route 142.

Follow Route 142 west past Short Beach and Farm River.
At top of small hill, turn left at blinking light into Fire Department property
Site is behind Fire Department building.

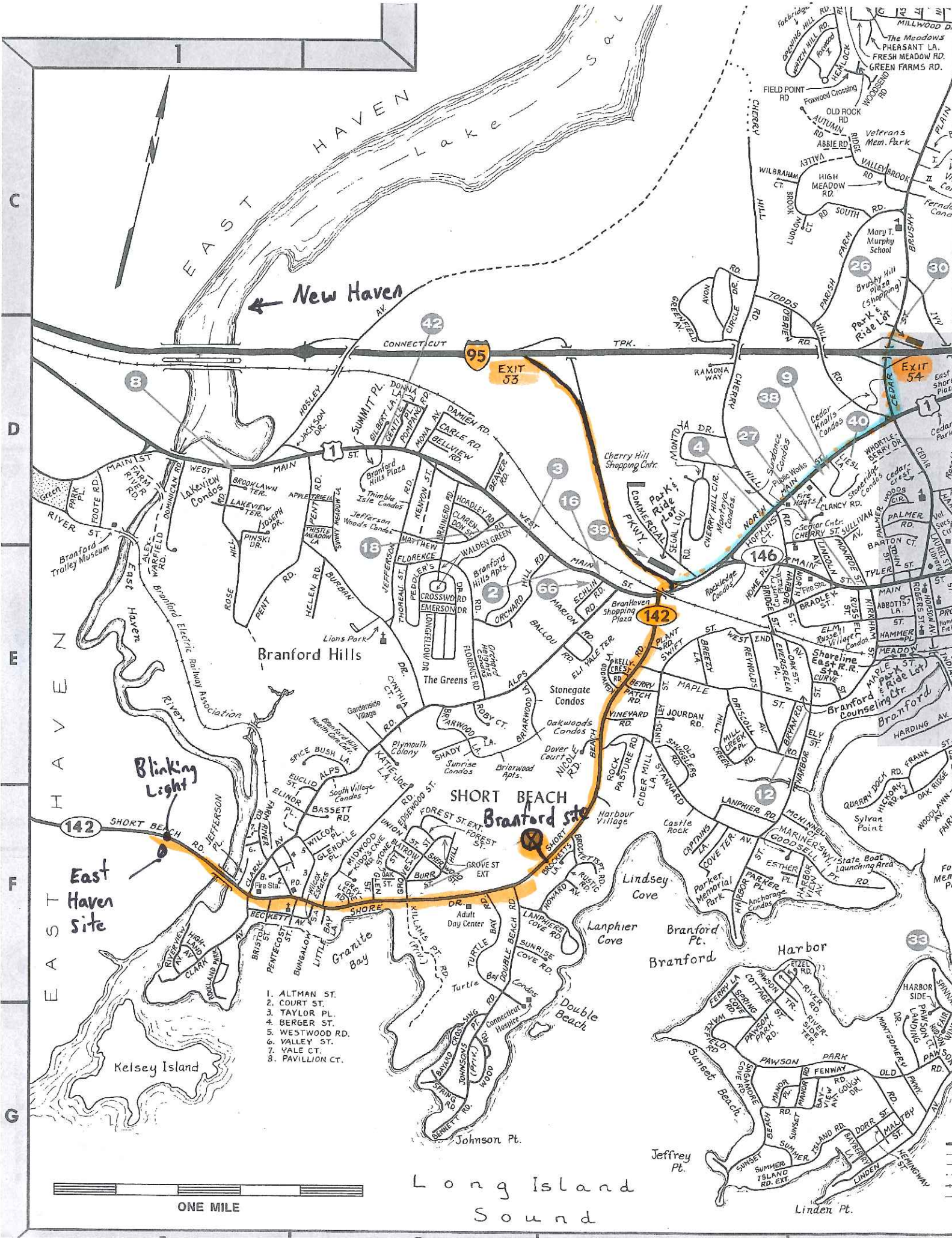
TO HEARING - East Haven Senior Center

From East Haven Site

Turn left out of Fire Department, following Route 142 west.
At T intersection, turn right, following Route 142 west.
Turn left onto Route 100 north (Walgreens on opposite corner).
Turn left onto Kirkham Avenue (at end of town green after passing brownstone church).
Senior Center is second driveway on right.

From I-95 in New Haven

Follow I-95 north to Exit 51, Frontage Road.
Turn right onto Kimberly Ave.
Turn left onto Main Street and follow to town green.
Turn right onto Kirkham at head of town green, Senior Center driveway on right.

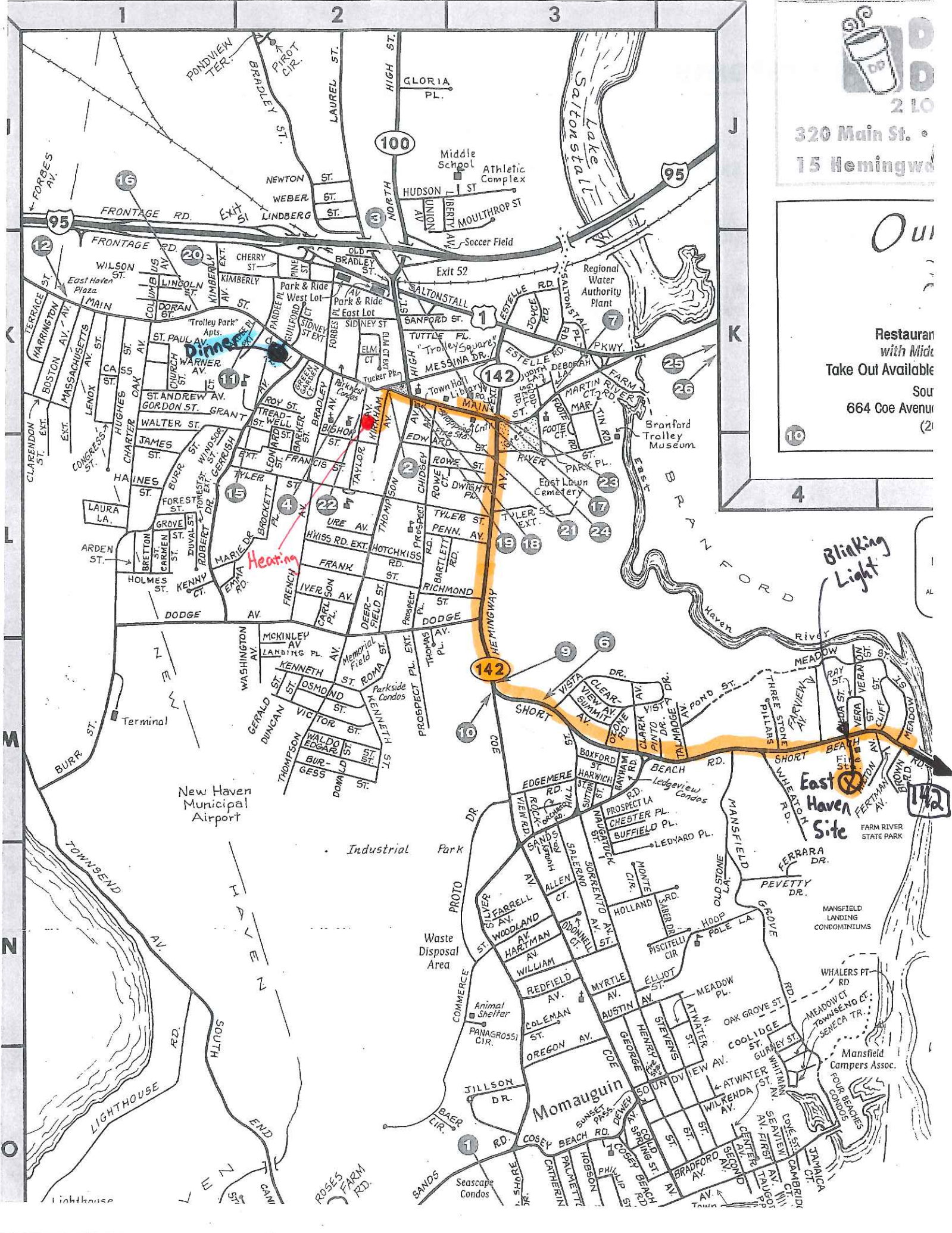
