Dear Chairman Stein and Members of the Connecticut Siting Council:

On behalf of Message Center Management ("MCM"), please accept this letter regarding the captioned Facility for which the Siting Council issued a Certificate of Environmental Compatibility and Public Need in Docket 425.

Condition 7 of the Decision and Order dated June 21, 2012 required the approved facility to be fully constructed and providing wireless services within eighteen months from the date of the mailing of the Council's Findings of Fact, Opinion, and Decision and Order. That date is estimated as December 21, 2013.

Message Center Management ("MCM") has commenced construction and the tower is currently scheduled for delivery in the second half of October. While Message Center Management ("MCM") is still working diligently to complete construction during this calendar year, this delivery schedule has the potential for weather related delays. As such, an extension of the certificate expiration date will be needed. No modifications or changes are proposed from the Development and Management Plan as approved by the Council on June 28, 2013.

We respectfully request an extension to June 30, 2014 which should assure sufficient time for the tower to be constructed and operational.
