We are writing to you on behalf of our client, New Cingular Wireless PCS, LLC ("AT&T") with respect to the above captioned matter involving a proposed wireless telecommunications tower facility to be located at 126 Transylvania Road in the Town of Roxbury, Connecticut. As you know, jurisdiction over such facilities rests exclusively with the State of Connecticut Siting Council pursuant to Section 16-50i and x of the Connecticut General Statutes.

Section 16-501(e) of the Connecticut General Statutes does nevertheless require that AT&T consult with a municipality prior to such an application being filed with the Siting Council. The purpose of such local consultation is to give the municipality in which a facility has been proposed an opportunity to provide the applicant with any recommendations or preferences it may have prior to the applicant's filing of an application.

The purpose of this letter is to formally notify you and commence the sixty-day consultation period that is required prior to AT&T's filing of any application with the Siting Council. Enclosed are four copies of a "Technical Report" for your review and consideration that includes information about the need for the proposed tower facility, a summary of the site selection process and the environmental effects of a tower that has been proposed. The Technical Report also includes a Visual Resource Evaluation including photosimulations of the proposed facility. We trust that this information will prove helpful to you and others in Roxbury in formulating any recommendations you may have about the proposal.

I am writing as a follow up to our prior conversation and your request for an electronic (scanned to CD) version of AT&T's Technical Report which is included herein. I am also enclosing four additional hardcopies of the Technical Report as requested by Zoning Enforcement Officer Mary Barton. Please also find included a September 21, 2009 letter from Michele Briggs, Manager Real Estate and Construction at AT&T, indicating that space on the tower and within the proposed compound will be made available to the Town for installation of emergency communications equipment without charge.

We are writing to you on behalf of our client, New Cingular Wireless PCS, LLC ("AT&T") with respect to the above captioned matter involving a proposed wireless telecommunications tower at 333 Southbury Road in the Town of Roxbury (the "Premises").

As discussed, consultants for AT&T are prepared to conduct a balloon float at the proposed tower location at the Premises this coming weekend. Our original date for the float was tomorrow November 12th with an alternate date of November 13th in case of inclement weather. At this time, forecasts for tomorrow call for wind gusts of up to 35 mph in and around Roxbury. We are writing to you on behalf of our client, New Cingular Wireless PCS, LLC ("AT&T") with respect to the captioned matter as part of AT&T's formal consultation with the Town of Roxbury under Section 16-50*l*(e) of the Connecticut General Statutes.

We had previously discussed with the Town AT&T's expected appearance before the Inland Wetlands Commission and we were advised by the Town, and as noted on its website, that this meeting was to take place on December 22nd. Just this week we were advised by Town officials that this Inland Wetland Commission's meeting was moved up to the 15th. It's not clear if the AT&T matter is on their agenda or not. In any event and in advance of any meeting in this regard, we are providing copies of the wetlands delineation report and field review map that was prepared for the project and which we just received from AT&T's soil scientists at VHB. As detailed in this report dated December 11th and included in Tab A of this letter, no wetlands will be impacted by the proposed communications facility.

Additionally and as you will recall, potential stormwater runoff from the proposed access drive was a concern raised by some neighbors as part of the Town consultation process. Enclosed please find revised project drawings behind Tab B that depict changes to the proposed access drive and additional mitigation measures controlling runoff from the property. The proposed access continues to utilize the existing drive and curb cut serving the property and the tower access continues at a point further uphill thus reducing the amount of new access drive further distant from Transylvania Road. A level spreader and other stormwater mitigation measures have also been included to take advantage of the natural terrain of the existing parcel and dissipate potential runoff from this limited use access drive.

You have also indicated your interest in understanding what other sites AT&T may be proposing in the Town of Roxbury. No additional sites are proposed in Roxbury at this time and one pending application exists over the southwestern border in the Town of Southbury. As we have discussed in the past, there are other existing coverage gaps in Roxbury which will necessitate additional siting long term in order to provide wireless service to the public.

In speaking with AT&T's radiofrequency engineers, we are advised that in addition to this project and the proposed site along State Route 67 heading south towards Southbury, AT&T has identified one other future search area in western Roxbury along Route 67 towards Bridgewater, an area which is not currently budgeted by AT&T for a site search. With respect to other coverage deficiencies in the Town, there are two additional search areas to the north that are outside of the Town of Roxbury but near the Town's border and coverage from any such sites can be anticipated in Roxbury. These existing gaps in wireless carrier coverage in portions of northern, western and southwestern Roxbury simply are not and can not be served by wireless carriers from the one existing site in Town at the former landfill. These areas will require additional utility infrastructure siting in the future in order to provide the public with safe and reliable wireless service.

We also want to confirm for you that AT&T's real estate consultants have followed up on the contact information you provided for a possible alternate site location for this project. Of note, this alternate site was pursued as part of AT&T's original site search. The owners initially indicated their interest in hosting a facility, however, issues related to access from Route 67 precluded any agreement and subsequent requests by AT&T for further information and confirmation of interest went unanswered. We have contacted the owner's representatives again and will keep you apprised of any new developments as to a possible alternate candidate site at that property.

At this point in time, AT&T has extended the consultation process beyond the 60 days provided for in State statutes as a courtesy to all involved and to provide you with information you've sought including a leaf off balloon test this past November which AT&T conducted on notice to the public. Our client is more than willing to appear before the Wetlands Commission and/or your Board of Selectmen to conclude the formal consultation process and receive any recommendations the Town and its agencies may have about the specific project at 126 Transylvania Road. We would like to complete that process by year end or shortly thereafter. Once the formal consultation has concluded our client will evaluate any Town recommendations and explore the suggested alternative further prior to any formal filing by it of an application with the State Siting Council.

This letter is in response to your request to have the Northwest Conservation District (NCD) perform an environmental review of the proposed access road to a cell tower compound. I reviewed the engineered design sheets (provided by Dewberry-Goodkind Inc.), the soils report (provided by Dean Gustafson, Professional Soil Scientist) and I visited the site on the afternoon of January 25, 2010. Please consider the following comments and recommendation when reviewing this proposal.

In discussing the project with the property owner during my site visit she indicated that she thought there was a septic system on both sides of her house (one for each bath). Split septic systems were a common practice during the decades when this house was constructed. If this house has a split system, the applicant should investigate the possibility that the road cut for the retaining wall will cut into one of the systems. If there is a septic system on the south side of the house alternative road or septic designs need to be considered.

My site visit coincided with a rain event that had just dropped 1.68 inches of rain on Roxbury. For comparison purposes, CT statistics indicate that a 3 inch rain event in 24 hours only occurs once every two years. Therefore, rainfall events of 1 to 2 inches occur much more frequently. During my site visit I also inspected Acorn Hill because it is an existing gravel road which is about the some length as the proposed road. Acorn Hill is a gravel drive that goes up the same hillside, and the soils have similar permeability as compared to the location of the proposed road. Both the Canton-Charlton (proposed drive) and Charlton-Chatfield (Acorn Hill) Soil Series have the same "moderate" permeability within the first 60 inches soil. I have attached pictures of Acorn Hill after the rain event mentioned above to illustrate what can happen when a gravel drive is attached to Transylvania Road with no stormwater flow management measures to minimize flow rates. (see photos on following page).

I believe that the liberal use of level spreaders along the proposed gravel drive servicing the cell tower compound will protect Transylvania Road from the event pictured above. I believe this because level spreaders will:

- 1) Take stormwater runoff away from the gravel drive,
- 2) Have some stormwater storage capacity,
- 3) Be located in soils that are well drained allowing for most of the stormwater runoff from the gravel drive to infiltrate.

The Northwest Conservation District (NCD) appreciates the opportunity to assist the Town of Roxbury with this land use change proposal. If this project is revised the NCD would welcome the opportunity to review an update of the proposal. If you have any questions, please do not hesitate to call me.

<u>Review of Cingular Wireless (A T &T) application to CT Siting Council and the Roxbury</u> <u>Zoning Regulations</u>

126 Transylvania Road, Roxbury, CT

Prepared by Mary Barton, Zoning and Wetlands Enforcement Officer

I have reviewed the Roxbury Zoning Regulations Section 5.11 Telecommunications, Antennae, Facilities and Antennae Towers including Personal Wireless Service Facilities and Towers and above referenced site plan to locate a Telecommunications facility at 126 Transylvania Road and the following are my comments:

- The proposed Tower is located in a Residence Zone C on a narrow dirt road known as Transylvania Road. While Transylvania Road is not a designated scenic road in Roxbury it is a beautiful road and a vibrant neighborhood in Roxbury. This area of Roxbury is one of the most populated areas of rural Roxbury dotted with residential dwellings.
- 2) The maintenance by the Town of Roxbury of a dirt road (Transylvania Road) in New England is a challenge to due to the seasonal changes in southern New England weather. Would it not make more sense to locate such a telecommunications facility on a paved road within the community rather than a dirt road with obvious drainage concerns that were discussed by the Roxbury Inland Wetlands Commission? Its residents know this area of Roxbury as an area of high ground water and drainage issues. A number of the residents of this area have spoken out at various town meetings on this application regarding the installation of extensive drainage on their private properties and their concerns with the Town's road drainage system within Transylvania Road.
- 3) The proposed tower is a 170-foot monopole enclosed in a fenced (chain link) compound area with proposed razor wire on top of the fence. The Town of Roxbury Zoning Regulations does not permit the use of Razor wire on top of a fence surrounding a Telecommunications facility. Roxbury is a rural community and the use of such razor wire is more appropriate in an urban setting. I am unclear in reviewing the site plan as to the exact height of the proposed chain link fence? Any fence over 6 feet in height must meet all of the zoning setbacks from all property lines. Will the chain link fence have any vinyl covering on the fence to permit the fence to blend in as much as possible with the natural landscape; a forested area. As this site is located is a Residential Zoning District the compound's fencing and access gate must be made to appear as

residential as possible and avoid the appearance of a commercial facility in a residential zoning district.

- 4) The monopole will be located within 395 feet of the existing dwelling located at 126 Transylvania Road; 460 feet and 510 feet to the closest abutting dwellings on Transylvania Road. Has the fall zone for the Tower been reviewed and determined if the fall zone for the Tower is in compliance with Section 5.11 of the Roxbury Zoning Regulations.
- 5) The existing conditions map does not clearly delineate the existing trees, the diameters of the existing trees and what trees will remain and what trees will be cleared from the site in order to install the access road and the compound for the Tower.
- 6) The Roxbury Zoning Regulations require if the facility is in a wooded area, a vegetated buffer strip of undisturbed trees shall be retained for at least 50 feet in width around the parameter except where the access drive is required. In addition to this preservation of the buffer, landscaping shall be required around the compound fence, which shall consist of a row of evergreen trees planted 10 feet on center maximum. The evergreen screen shall be a minimum of 6 feet at planting and shall be reasonably projected to grow to a minimum of 15 feet in height at maturity. This landscaping shall screen the facility from the view of streets (Transylvania Road) and neighboring properties. The plans I reviewed do not address the preservation of a landscaped buffer or the details on the plantings around the compound area.
- 7) The Roxbury Zoning Regulations Section 5.11 .10 c. have specific requirements for signage. The site plan does not indicate any proposed signage.
- 8) What is the finish of the tower? Will the Tower be painted blue, gray or made to look like a tree?
- 9) The structure(s) to house the equipment for the Tower appear to be a flat roofed commercial building. Is this building metal or masonry? This proposed building does not appear residential in nature and will not blend in with the residential character of the neighborhood. How many more potential buildings will be constructed on this site to house equipment? Who will insure that any additional structures will be residential in character? Will A T & T notify future carriers of the requirement and desire of the Town of Roxbury that any such future structures that are built on this site be built to appear residential in character. How will this requirement be communicated to future carriers?

- 10) Have there been any additional studies regarding endangered species by CT DEP in this area of Roxbury. It is my understanding that a turtle on the Endangered Species list was discovered living in this area of Roxbury.
- 11) An elevation drawing showing the ridgeline on all sides of the proposed tower and showing the Tower and facilities on the ridge line as seen from Town hall was not provided for review by the community.
- 12) The Community is concerned about the impact of the proposed Tower on human health. Has there been any study completed indicating potential health impacts to the residents of one of the most densely populated areas in Roxbury.
- 13) 126 Transylvania Road in located in a Residence Zone C. This district includes the Town of Roxbury's reserved open space and numerous scenic and rugged topographic features worthy of conservation in their natural state. It is a major objective of the Roxbury Zoning Regulations to preserve the rural, wooded, agricultural character of Roxbury. The location of a Telecommunications facility at 126 Transyvania Road in Roxbury is the polar opposite of the goals of the Town of Roxbury Zoning Commission.
- 14) The facility does not appear to have any proposed exterior lighting on site? What happens when there is an emergency and the site must be accessed during the evening hours? There are no streetlights on Transylvania Road.
