# Docket No. 428 Pre-Hearing Questions Set Three

### **General Questions for both Sites**

- 1. On page 12 of the Application, AT&T notes that public meetings regarding the Site B facility were held in the Town of Roxbury on September 24, 2012 and December 15, 2012. On page 13 of the Application, AT&T notes that a technical report providing the details of Site A was provided to the Town of Roxbury by letter dated September 30, 2012. Were all three of these dates intended to be 2011 rather than 2012?
- 2. In the Site Search Summary of the Application, AT&T lists Errico Nos. 1 through 4 as the first four sites on the list. Are Errico sites Nos. 1 through 3 located on the Site B property? If yes, identify where on the subject property. If no, provide the address(es). Is Wilder #2 located on the same parcel as Wilder #1? Explain.
- 3. How many levels (arrays) of antennas and how much additional height would be required to accommodate flush-mounted antennas on a tower at either site?
- 4. How many gallons of fuel would the backup generator hold?
- 5. Would the generator have containment in the event of a fuel, oil, or coolant leak?
- 6. How long could the battery backup supply power in the event that the generator fails to start?
- 7. Explain in detail why Site B is preferable from an RF perspective.
- 8. Provide a coverage plot from the Town property on Squire Road.

# Site A: Tax Assessor Parcel ID #32-008, off Route 67 Questions

- 9. The January 25, 2011 letter from VHB, Inc. (VHB) to the State Historic Preservation Office is provided under Tab B of the Application. This letter has no signature page. Is there a second page to this letter? If yes, provide the complete letter.
- 10. Provide the address and owner of the property nearest (970 feet southeast) Site A?
- 11. Provide the total length of the Site A access drive from Route 67 to the tower compound.

# Site B: 126 Transylvania Road Questions

12. For Site A, VHB's Eastern Box Turtle Protection Program is provided. Would this also be applicable to Site B?
