TO: FIELD REVIEW OF SITE – 180 Dr. Martin Luther King, Jr. Drive, Norwalk

Via Interstate 91 South

Proceed on I-91 South towards New Haven.
Take I-95 South.
Follow I-95 South directions below.

Via Route 15 South

Take Route 15 South towards Route 8 South.
Follow Route 8 South directions below.

Via Route 8 South

Take Route 8 South towards Bridgeport.
Take I-95 South.
Follow I-95 South directions below.

Via I-95 South (from points east of Norwalk)

Proceed on I-95 South.
Take Exit 15 (Route 7 towards Norwalk / Danbury).
Bear right onto the exit towards Maritime Aquarium / South Norwalk.
Turn left at the traffic light onto West Avenue.
Proceed on West Avenue for about 0.5 miles.
West Avenue becomes Dr. Martin Luther King Drive.
Continue straight onto Dr. Martin Luther King Drive.
Proceed on Dr. Martin Luther King Drive for about 0.8 miles.
The site is located on the right at 180 Dr. Martin Luther King Drive.

Via I-95 North (from points west of Norwalk, e.g. Stamford)

Proceed on I-95 North.
Take Exit 14 (towards South Norwalk).
Turn right onto Fairfield Avenue.
Proceed on Fairfield Avenue for about 0.4 miles.
Fairfield Avenue becomes West Washington Street.
Turn right onto Dr. Martin Luther King Drive.
Proceed on Dr. Martin Luther King Drive for about 0.6 miles.
The site is located on the right at 180 Dr. Martin Luther King Drive.

FROM: SITE – 180 Dr. Martin Luther King, Jr. Drive, Norwalk

Turn left onto Dr. Martin Luther King, Jr. Drive.
Proceed on Dr. Martin Luther King Drive for about 0.8 miles.
Dr. Martin Luther King Drive becomes West Avenue.
Continue straight on West Avenue for about 0.3 miles.
Merge onto Interstate 95 North (towards New Haven).
Proceed on I-95 North for 0.6 miles. (Stay in right lane.)
Take Exit 16 (toward East Norwalk).
Bear left towards Route 1.
Turn left onto East Avenue.
Proceed straight on East Avenue for about 0.4 miles.
Just past the Norwalk City Hall is Sunset Hill Avenue.
Turn right onto Sunset Hill Avenue.
Turn right into the parking area.

Via Interstate 91 South

Proceed on I-91 South towards New Haven.
Take I-95 South.
Follow I-95 South directions below.

Via Route 15 South

Take Route 15 South towards Route 8 South.
Follow Route 8 South directions below.

Via Route 8 South

Take Route 8 South towards Bridgeport.
Take I-95 South.
Follow I-95 South directions below.

Via I-95 South (from points east of Norwalk)

Proceed on I-95 South.
Take Exit 16 (towards East Norwalk).
Bear right to take ramp towards Route 1.
Bear right onto East Avenue.
Proceed on East Avenue for about 0.3 miles.
Just past the Norwalk City Hall is Sunset Hill Avenue.
Turn right onto Sunset Hill Avenue.
Turn right into the parking area.

Via I-95 North (from points west of Norwalk, e.g. Stamford)

Proceed on I-95 North.

Take Exit 16 (towards East Norwalk).

Bear left to take ramp towards Route 1.

Bear left onto East Avenue.

Proceed on East Avenue for about 0.4 miles.

Just past the Norwalk City Hall is Sunset Hill Avenue.

Turn right onto Sunset Hill Avenue.

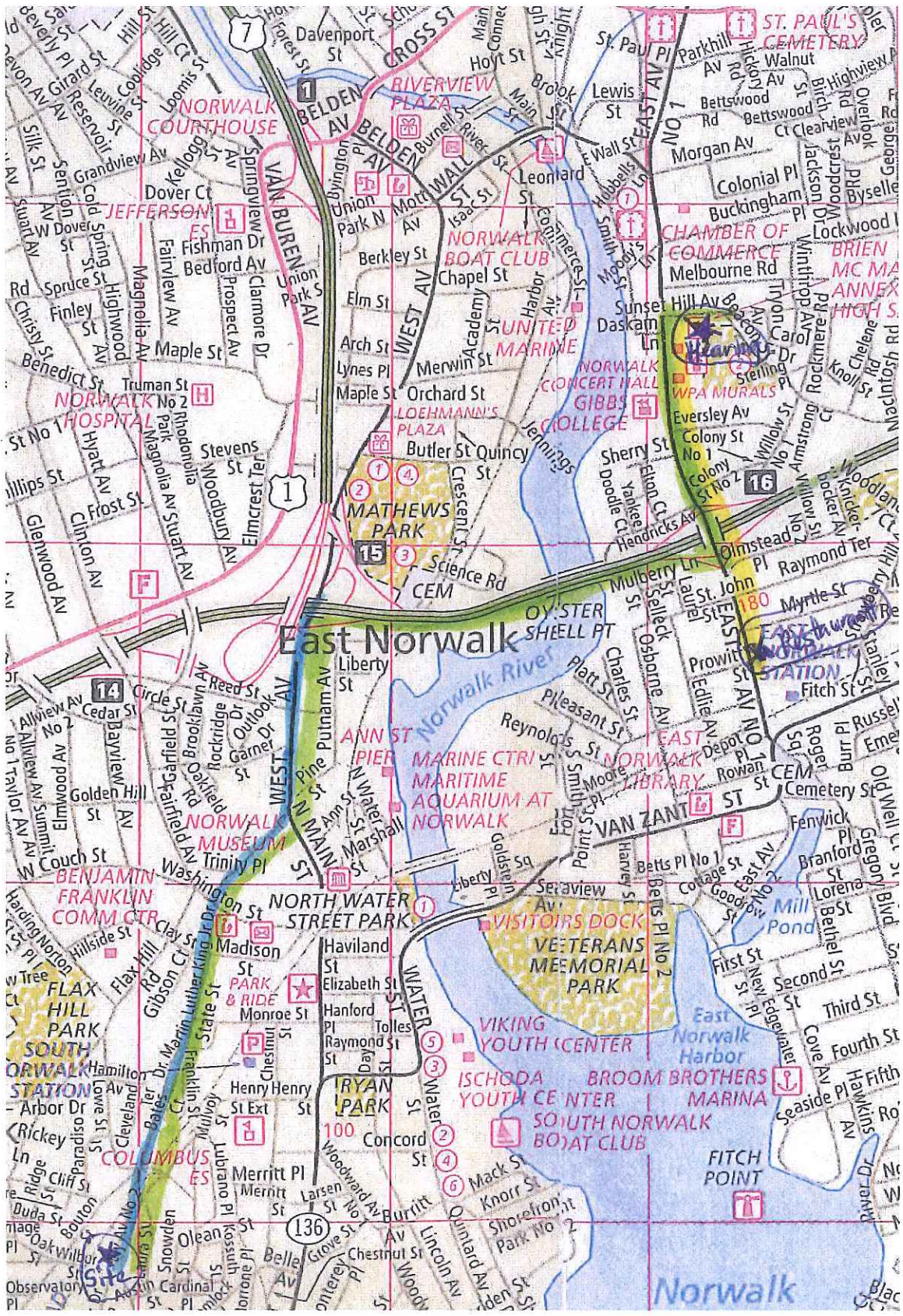
Turn right into the parking area.

TO RESTAURANT: Penny's Diner, 212 East Avenue, Norwalk
FROM HEARING LOCATION: Norwalk City Hall, 125 East Avenue,
Norwalk

Turn left onto East Avenue.

Proceed on East Avenue for about 0.6 miles.
