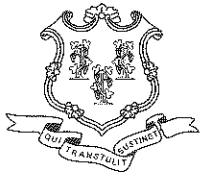

NOTICE OF HEARING
FEASIBILITY STUDY OF BACKUP POWER REQUIREMENTS

Connecticut Siting Council

The Connecticut Siting Council (Council) will conduct a public hearing on Thursday, November 1, 2012, to study the feasibility of backup power requirements for telecommunications towers and antennas. The hearing will be held in Hearing Room Two, Ten Franklin Square, New Britain, Connecticut, beginning at 11 AM. The hearing is being held pursuant to Section 8 of Public Act 12-148, An Act Enhancing Emergency Preparedness and Response. The Public Act designates the following as participants to this proceeding: providers of mobile radio service, as defined in 47 CFR 20.3; the Department of Energy and Environmental Protection; the Department of Emergency Services and Public Protection; and the Public Utilities Regulatory Authority. Any person seeking to be a participant to the proceeding may file a written request to be so designated at the office of the Council, 10 Franklin Square, New Britain, Connecticut 06051, on or before October 25, 2012. Participants are requested to submit pre-filed testimony to the Council on or before October 25, 2012. Participants are required to serve the Council with an original and 15 copies and all other participants with one copy of any material submitted to this docket. A list of participants of record is available from the Council. Any person who is not a participant to the proceeding may file a written statement with the Council on or before the date of the hearing or may make an oral statement at the hearing. All testimony at the hearing will be taken under oath, and each witness will be subject to cross-examination by the Council and all participants. The record of this proceeding is available for public inspection at the office of the Council, 10 Franklin Square, New Britain, Connecticut 06051. Requests for information in alternative formats or for sign-language interpreter services must be submitted in writing by October 25, 2012.
