We are writing to you on behalf of our clients Message Center Management, Inc. and New Cingular Wireless PCS, LLC (“AT&T”) (together “Applicants”) with respect to the above referenced matter and our clients’ intent to file an application with the State of Connecticut Siting Council for approval of one (1) proposed wireless communications tower facility (the “Facility”) within the Town of East Hartford.

State law requires that record owners of property abutting a parcel on which a facility is proposed be sent notice of an applicant’s intent to file an application with the Siting Council. Two alternative site locations are being proposed by the Applicants and only one facility would be constructed. Candidate A is located at 465 Hills Street and is identified as parcel number 63-348 by the East Hartford Tax Assessor. Candidate B is located at 56 Hills Street and is identified as parcel number 42-370 by the East Hartford Tax Assessor. Included with this letter please find a Notice of this application with details of the proposed Candidate A and B Facilities. Only one facility would be constructed.

The location, height and other features of the Candidate A and B Facilities are subject to review and potential change by the Connecticut Siting Council under the provisions of Connecticut General Statutes §16-50g et seq.

If you have any questions concerning this application, please contact the Connecticut Siting Council or the undersigned after February 12, 2013, the date which the application is expected to be on file.

NOTICE

Notice is hereby given, pursuant to Section 16-50I(b) of the Connecticut General Statutes and Section 16-50I-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council ("Siting Council") on or after February 12, 2013 by Message Center Management ("MCM") and New Cingular Wireless ("AT&T") (together the "Applicants") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in East Hartford, Connecticut. Two alternative site locations are being proposed by the Applicants and only one facility ("Facility") would be constructed.

Candidate A is located at 465 Hills Street and identified as parcel number 63-348 by the East Hartford Tax Assessor. The proposed Candidate A Facility is located in the central portion of the parcel and is proposed as a 100' above ground level (AGL) self-supporting monopole tower with evergreen-type camouflaging reaching to 107' AGL. The tower would be expandable to 120' AGL. The tower, antennas and ground equipment will be located within a 63' x 75' fenced equipment compound designed to accommodate unmanned equipment either in single-story equipment buildings or on a concrete pad. Access to the Facility as proposed would be over a new 400' gravel access drive from Eagle Court. Utility connections would be extended underground from an existing utility pole near Eagle Court.

Candidate B is located at 56 Hills Street and identified as parcel number 42-370 by the East Hartford Tax Assessor. The proposed Candidate B Facility is located in the northern portion of the parcel and is proposed as a 100' AGL self-supporting monopole tower with evergreen-type camouflaging reaching to 107' AGL. The tower would be expandable to 120' AGL. The tower, antennas and ground equipment will be located within a 50' x 50' fenced equipment compound designed to accommodate unmanned equipment in either single-story equipment buildings or on a concrete pad. Access to the Facility will be from Hills Street over approximately 280' of an existing access drive then along an existing dirt drive that will be upgraded with gravel approximately 250' in length to the proposed equipment compound. Utility connections for the proposed access drive would be extended underground from an existing pole on site.

The location, height and other features of the proposed Candidate Facilities are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq.

A facility is proposed to allow AT&T to provide service in this area of the State. The Application explains the need, purpose and benefits of the proposed Candidate Facilities and also describes the environmental impacts of each Candidate Facility. Either Candidate Facility would be available for co-location by other wireless carriers.

Balloons, representative of the proposed height of the each of the candidate towers, will be flown at each candidate site on the first day of the Siting Council public hearing on the Application, which will take place in Town, or such other date specified by the Siting Council and a time to be determined by the Siting Council, but anticipated to be between the hours of 12pm and 5pm.
