## NOTICE

Notice is hereby given, pursuant to Section 16-50*l*(b) of the Connecticut General Statutes and Section 16-50*l*-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council ("Siting Council") on or after March 4, 2013 by New Cingular Wireless PCS, LLC ("AT&T" or the "Applicant") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in Bridgewater, Connecticut.

The proposed facility is located at 111 Second Hill Road and identified as parcel number 28/50 by the Bridgewater Tax Assessor. The proposed facility is located in the northeast portion of the 4.5 acre parcel and is proposed as a 160-foot self-supporting tower.
