### Directions to 596 Pendleton Hill Road, Voluntown

## From Hartford, New Britain, Enfield, Meriden, Wolcott:

- Take Route 2 eastbound to Norwich and switch to I-395 northbound.
- From I-395, take Exit 85 (Routes 164 and 138/Preston City and Pachaug).
- At first traffic light after exiting, continue straight ahead to follow signs to Route 138. At second traffic light, turn right to follow Route 138.
- Follow Route 138 to intersection with Route 49 (approximately .4 mile after Voluntown Town Hall, which will be on your left).
- At Route 49 intersection, turn right and then a quick left to follow Route 49.
- Site 1 will be approximately 2.6 miles on right after making the quick left onto Route 49 Look for the logs piled up.

#### From Milford and Stamford

- Take I-95 eastbound(northbound) to I-395 northbound.
- From I-395, take Exit 85 (Routes 164 and 138/Preston City and Pachaug) and follow above directions.

# From Stonington

- Take I-95 north to Exit 92 (Routes 2 and 49/No. Stonington and Pawcatuck).
- From exit ramp follow signs to Route 49 to travel north to Voluntown.
- Site 1 will be on left look for piles of logs.

#### To Voluntown Town Hall

- From Site 2, return to Route 49, turn right and follow to Route 138.
- Turn left onto Route 138. Town Hall will be approximately .4 mile on right turn right between Town Hall and Sunny's Supermarket.
- Parking for Town Hall is behind building.

### To Restaurant

Dinner will be at Town Pizza/Olde Town Tavern in Voluntown.

- From Voluntown Town Hall, turn left onto Route 138. Restaurant will be approximately .6 mile on right.
- The restaurant is in a small strip plaza that is hidden by trees when approaching from the direction of the town hall.
