NOTICE

Notice is hereby given, pursuant to Section 16-50*l*(b) of the Connecticut General Statutes and Section 16-50*l*-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council ("Siting Council") on or after October 28, 2013 by New Cingular Wireless PCS, LLC ("AT&T" or the "Applicant") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in New Milford, Connecticut.

The proposed facility is to be located at the approximately 168.5 acre FirstLight Hydro Generating Company parcel on Kent Road and identified as Map 83, Lot 4 by the New Milford Tax Assessor. The proposed facility consists of a 150-foot self-supporting monopole tower and a 75' x 75' tower compound located in the southern portion of the parcel. An associated 12' x 20' equipment shelter would be installed at the tower base together with a back-up power generator in the compound. The compound and tower will include space for other carriers as well as emergency communications equipment and be enclosed by an eight (8) foot tall chain link fence. Vehicular access to the Facility would be provided from Kent Road over the existing paved driveway and then along a new gravel driveway to the tower compound.

The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq.

The facility is being proposed to allow AT&T to provide service in this area of the State. The Application explains the need, purpose and benefits of the facility and also describes the environmental impacts of the proposed facility. The facility will be available for co-location by other wireless carriers.

A balloon, representative of the proposed height of the facility, will be flown at the proposed site on the first day of the Siting Council public hearing on the Application, which will take place in Town, or such other date specified by the Siting Council and a time to be determined by the Siting Council, but anticipated to be between the hours of 12pm and 5pm.
