
Cellco objects to the Intervenors' request to postpone, in its entirety, the August 12, 2014 continued hearing, but does not object if the August 12, 2014 hearing is limited in scope. Cellco is currently compiling the additional information that the Council requested during the July 17, 2014 hearing. Cellco hopes to have this information and responses to some or all of Dr. Klemen's July 22, 2014 questions filed with the Council on August 5, 2014. Cellco's witnesses will be prepared to respond to additional cross examination by the Council, Council staff and the Intervenors on August 12, 2014.

Cellco does not object to the scheduling of an additional hearing, tentatively September 16, 2014, for the presentation of the Intervenors' affirmative case and cross examination by the

Council, Council staff and Cellco. Cellco does ask however, that the Council require the Intervenor to file all of their exhibits, reports and pre-filed testimony, on or before September 2, 2014 to provide Cellco with adequate time to prepare for the September 16, 2014 continued hearing and avoid further delay of this proceeding.
