Notice is hereby given, pursuant to Section 16-50*l*(b) of the Connecticut General Statutes and Section 16-50*l*-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Sting Council ("Siting Council") on or after April 18, 2014 by Message Center Management ("MCM") and New Cingular Wireless ("AT&T") (together the "Applicants") for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in Redding, Connecticut.

The proposed tower facility consists of constructing a monopole tower and an equipment compound at the Redding Ridge Fire Department site, owned by Redding Fire District 1, with an address of 186 Black Rock Turnpike in the Town of Redding and identified on the Tax Assessor's Map as Map 23, Lot 35 (the "Property").

The Applicants propose to replace an existing 80' above grade level ("AGL") lattice tower with a self-supporting 150' AGL monopole tower which will accommodate antennas belonging to federally licensed wireless carriers as well as emergency/municipal communications antennas. AT&T would install up to twelve (12) panel antennas at a centerline height of approximately 150' AGL and some additional equipment on the tower. An associated 12' x 20' equipment shelter would be installed at the tower base on a concrete pad within a compound together with provisions for a back-up power generator connection. The compound will include space for equipment of other carriers as well as municipal equipment and be enclosed by an eight (8) foot tall chain link fence. Vehicle access to the facility would be provided from Black Rock Turnpike over an existing bituminous parking/driveway area that also serves the fire department building. Utility connections would be routed underground from an existing utility pole #4259 located on site.

The location, height and other features of the proposed Facility are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq.

The Facility is proposed to allow AT&T to provide service in this area of the State. The Application will explain the need, purpose and benefits of the proposed Facility and also describes the environmental impact of the Facility. The Facility would be available for co-location by other wireless carriers.
