Dear Chairman Stein and Executive Director Bachman:

Please accept this letter from Homeland Towers, LLC as holder of the Certificate of Environmental Compatibility and Public Need issued by the Siting Council in Docket 451 ("Certificate"). Condition 6 of the Decision and Order dated January 14, 2015 required the approved facility to be fully constructed and providing wireless services within eighteen (18) months from the date of the mailing of the Council's Findings of Fact, Opinion, and Decision and Order.

Although the tower is constructed and the Town's public safety equipment is installed, AT&T continues at this time to make arrangements for the installation of their communication data service to the tower site. In keeping with Condition 7 of the Decision and Order, we respectfully request an extension of the Certificate's allowed completion time for an additional eighteen (18) months which would extend out to January 14, 2018.

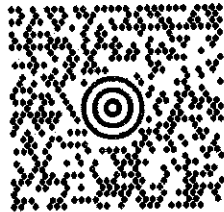

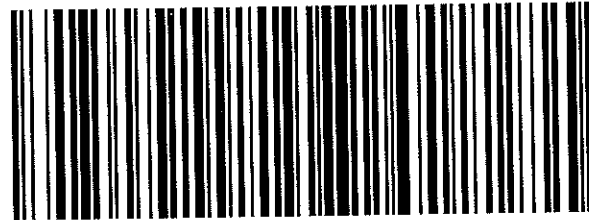
