RE: **DOCKET NO. 452** – InSite Towers Development, LLC Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at Salisbury Tax Assessor Map 16 Lot 5, 250 Canaan Road, Salisbury, Connecticut. **D&M Plan Revision.**

Dear Attorney Chiocchio:

The Connecticut Siting Council (Council) is in receipt of your correspondence dated December 14, 2020 regarding the revision to the Development and Management (D&M) Plan for the above-referenced site that was approved by the Council on March 6, 2015.

The revisions include, but are not limited to, the following:

- a) Change the quantity of antennas from 12 to 6;
- b) Reduce the length of the T-arm face from 10 feet to 8 feet (due to less antennas);
- c) Change the quantity of remote radio heads from 21 to 9;
- d) Install a 20-kW diesel generator in the northern portion of the compound in lieu of a 35-kW diesel generator in the southern portion of the compound; and
- e) Install a 6-foot 8-inch by 6-foot 8-inch walk-in cabinet shelter in the northern portion of the compound in lieu of an 11-foot 5-inches by 16 foot equipment shelter in the southern portion of the compound.

Pursuant to Regulations of Connecticut State Agencies §16-50j-77(b), your request for revision to the D&M Plan is hereby approved.

This approval applies only to the D&M Plan revision dated December 14, 2020. Any significant changes to the D&M Plan require advance Council notification and approval.

Please be advised that deviations from this plan are enforceable under the provisions of the Connecticut General Statutes § 16-50u. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to Regulations of Connecticut State Agencies Section 16-50j-77.

Thank you for your attention and cooperation.
